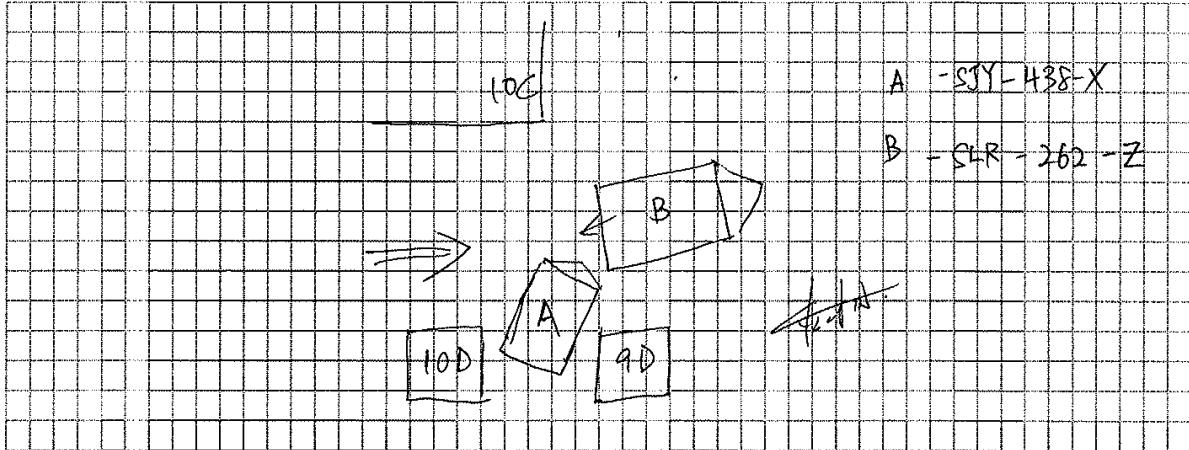

I also noticed that the other party was reversing. I stayed in the lot to wait as I am unclear about his intention. Then the other party moved in forward which was towards an parallel parking lot. I move my car forward a bit and stop for him to complete his parking. But when I realised that he <sup>then</sup> signaled ~~reverse~~ reversing lights, I do not have time to react and the accident occurred. I noted that the directional arrow on the floor was pointing ~~to the right~~ from the left to right and it is a single direction only.

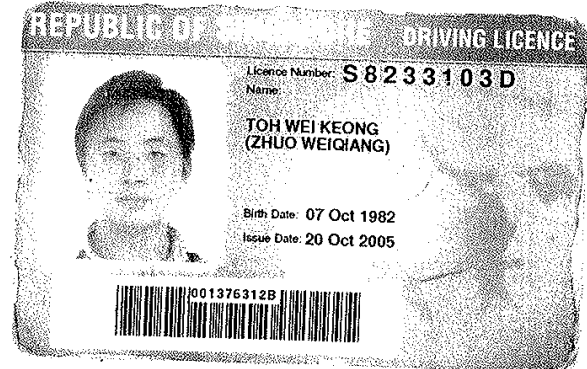

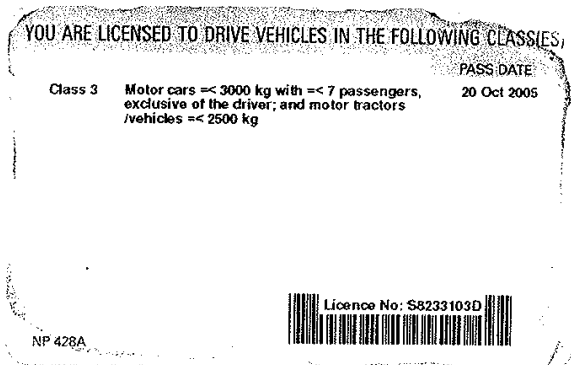

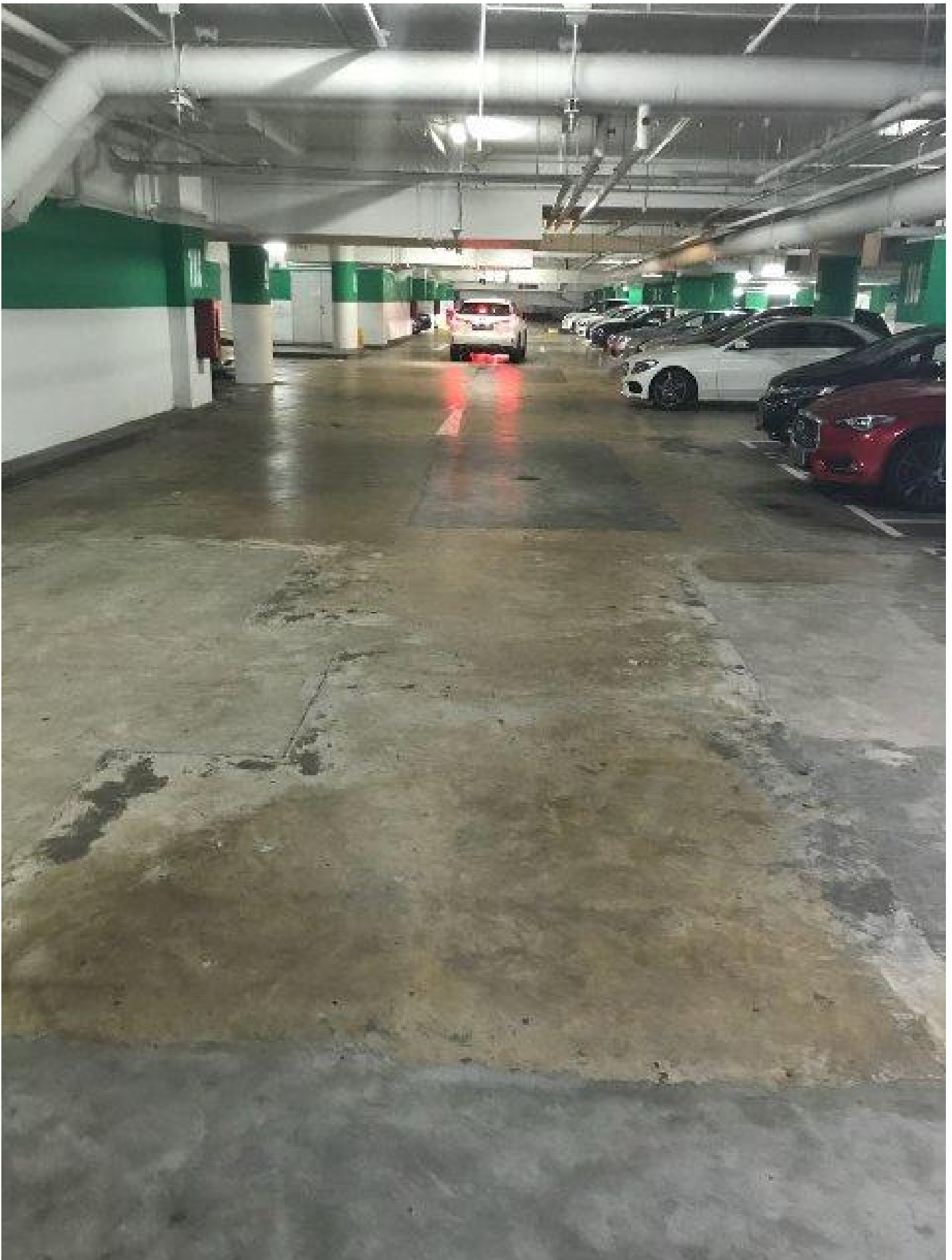
