Circumstances of Accident

REFER TO POLICE REPORT - T/20180530/2116 LODGED AT BEDOK NPP. ON THE 26/05/2018 AT ABOUT 1415HRS, MY HUSBAND BY THE NAME OF LIM SONG LIAN (S1569639G, HP: 90100694) WAS DRIVING THE CAR BEARING THE REGISTRATION PLATE NUMBER SKX8586S ALONG NEW UPPER CHANGI ROAD HEADING TOWARDS CHANGI ROAD. OUR CAR WAS TRAVELLING ON THE EXTREME RIGHT LANE WITH NO VEHICLES IN FRONT. AS I WAS APPROACHING THE JUNCTION OF NEW UPPER CHANGI ROAD AND BEDOK NORTH AVENUE 3 (NEAR TO BEDOK COMMUNITY CENTRE) WITH THE INTENTION TO TURN RIGHT INTO BEDOK NORTH AVENUE 3, A BLUE IN COLOUR TAXI SUDDENLY COLLIDED WITH OUR CAR FROM AN UNKNOWN DIRECTION. THE SAID TAXI HIT ONTO THE FRONT LEFT PASSENGER DOOR AND IT SUBSEQUENTLY DRAGGED THE LEFT SIDE OF OUR CAR AS OUR CAR WAS STILL MOVING. BOTH THE TAXI DRIVER AND MY HUSBAND STOPPED BY THE SIDE OF THE ROAD TO EXCHANGE PARTICULARS BEFORE GOING OUR SEPARATE WAYS. ON THE MORNING OF 27/05/2018, I WOKE UP AND FELT PAIN COMING FROM MY LOWER BACK AND MY NECK. I INITIALLY THOUGHT IT WAS A TEMPORARY PAIN HOWEVER, IT GOT WORSE AFTER A FEW DAYS. AS SUCH, I WENT TO CONSULT A DOCTOR ON THE 29/05/2018 AND WAS GIVEN THREE DAYS OF MEDICAL LEAVE. I WAS SCHEDULED FOR PHYSIOTHERAPY SESSION AS WELL.

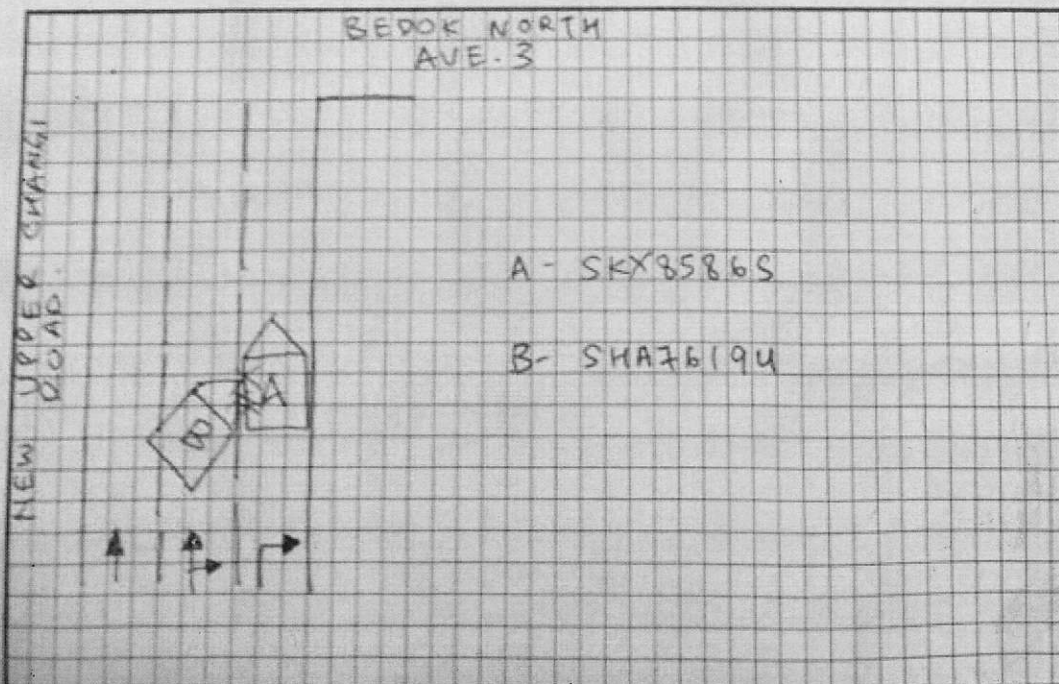



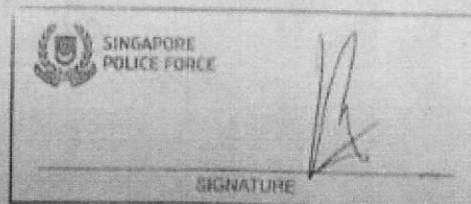

Brief Details.

On the 26/05/2018 at about 1415 hours, my husband by the name of Lim Song Lian (S1569639G, HP: 90100694) was driving the car bearing the registration plate number SKX8586S along New Upper Changi Road heading towards Changi Road. Our car was travelling on the extreme right lane with no vehicles in front. As I was approaching the junction of New Upper Changi Road and Bedok North Avenue 3 (near to Bedok Community Centre) with the intention to turn right into Bedok North Avenue 3, a blue in colour taxi suddenly collided with our car from an unknown direction. The said taxi hit onto the front left passenger door and it subsequently dragged the left side of our car as our car was still moving. Both the taxi driver and my husband stopped by the side of the road to exchange particulars before going our separate ways.

On the morning of 27/05/2018, I woke up and felt pain coming from my lower back and my neck. I initially thought it was a temporary pain however, it got worse after a few days. As such, I went to consult a doctor on the 29/05/2018 and was given three days of medical leave. I was scheduled for physiotherapy sessions as well.
