

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On Tuesday 6/6/2018 @ about 7.30pm, I was driving my passengers towards Jln Klang Barat along Jln Bukit Merah. Traffic was moderately light and I was driving at about 50 km/h. I was on the centre lane and didn't realise and observe that traffic ahead had slowed down somewhat. In that moment as I signalled to move left to make a turn ahead to my passengers' destination, I crashed into a car with car registration number SJR 6575E and which in turn collided into the 1st car registration SLR 2549J.


In our initial observation and as there was no human injury, we proceeded to move the cars to the side of the road, slightly away from the crash site. It was a 3 car collision.


After exchanging personal particulars and taking photos of the damage, we left the scene.


