Nissan car bearing plate no. SKH2545J hit the rear of the mentioned black car. The black car then stopped and the driver went out of his car to make a check.

As both the black and white cars were stationary, I then drove my car to overtake the black car to continue my journey. After a few minutes later, I was still at the sheltered area of the Woodlands checkpoint as there was still a jam. I then noticed that the black car earlier had overtook my car and the white Nissan car bearing plate no. SKH2545J was behind my car. The white car was driving very close to the rear of my car and subsequently to the right side of my car. The white car then got very close to my car on my right and it's left side mirror then hit my right side mirror.

There was no damage on my right side mirror however I stopped my car and wind down my driver side mirror to notify the driver that he was too close and it will cause an accident if he continues driving however the driver ignored me and continued to drive forward. When the white car drove forward, the left front passenger door hit the front right bumper and the fender of my car which caused dents and scratches, and the force of the collision actually moved my car slightly to the left. The white car driver did not stop after the collision and continued driving forward.

At that time, there was a CISCO officer nearby and I told him about the accident and he assisted me to ask the white car driver to stop by the side. I then moved my car to the side as well and spoke to white car driver. The driver then asked me how I drive my car when it was clearly his fault. I then asked to exchange particulars however the driver refused to furnish his particulars and told me to just file an insurance claim. The driver then went back to his car and drove off. There was a male passenger at the front passenger seat of the white car. I have an in-car camera installed in my car and I have the video
