SKETCH PLAN





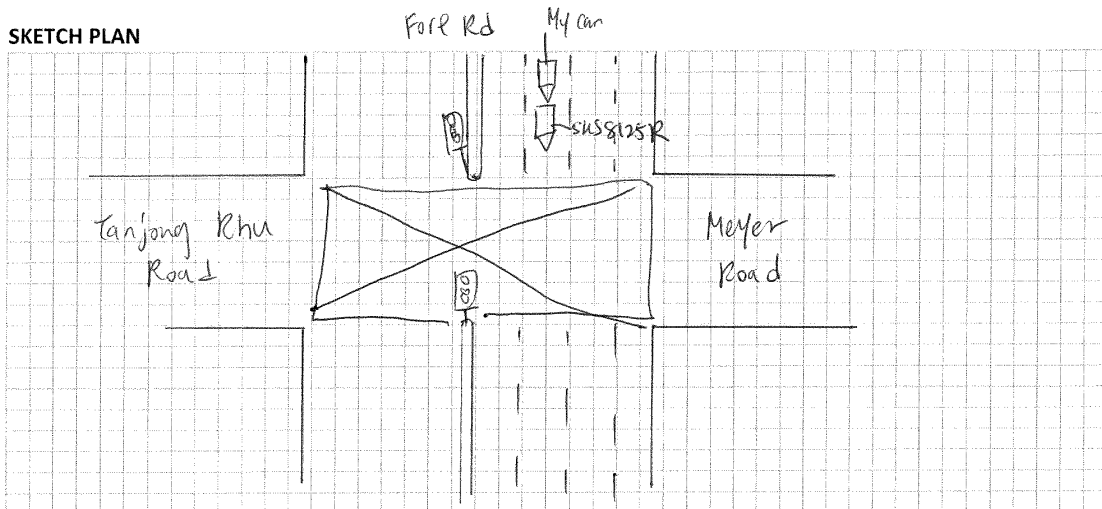
