<p>I was driving M10 46201 (MUV) with vehicle commander L1P Lim Ding Wei. They had exited (T/E) exit and turning onto Yio Chu Kang Road. It was a 3 lane road and PTE Junqi was in the second lane. A black civilian motorcycle Yamaha MT 09 Tracer number plate Fy533B was in the third lane. In the midst of turning right, a civilian car on the first lane swerved and cut into PTE Junqi's vehicle's lane. PTE Junqi reacted to this by swerving left a little bit, but the MUV was still within the second lane and did not swerve into the first lane. This resulted in front left side of his MUV to tap onto the right rear of motorcycle Fy533B, resulting in the civilian motorcyclist to lose balance and fall onto the sidewalk on the front left hand side. The civilian motorcycle has scratches on the rear right hand side the civilian's box. And alignment is off with no other noticeable damages.</p>

<p>I am the Vehicle Commander of an MUV, MUV 48261, and the Convoy Commander. From what I saw, the driver of the MUV is turning right into Yee Chu Kang Road, towards Upper Thomson Road, under CTE Phang, while maintaining his lane in lane 2. Just when the vehicle was about to complete the turn, the driver swerve towards left slightly to avoid an on^{oncoming} oncoming civilian car that is abruptly cutting in to our lane lane from lane 3. I reacted and tried to warn the driver about a motorcycle that is passing closely with us, travelling on the right side of lane 3. However, it still can't avoid the and thus resulting in the MUV that left to come in contact with the bike's rear right box. This caused the rider to lose balance and while trying to regain balance, he mounted the kerb and took his fall into into the pedestrian pavement.</p> <p>And that is all I have to say.</p>


