**CONTINUATION OF REPORT**

**Brief Details:**

I am a SAF reservist NSmen, and on 07/06/2018 at about 0815hrs I drew the SAF vehicle (MID34459) from Jurong Island SAF Ops Room.

On the same day at about 0950hrs I was driving the said vehicle along Meranti Rd towards Banyan Ave on the center lane of the 3-lane road. Slightly before the T-junction to Banyan Ave, the bus in-front of my vehicle suddenly stopped, as I tried slowing down but could not stop in time. Thus resulting to a collision between my vehicle to the rear of the bus in-front.

*was not a personal*  
As a result of the collision, we noticed smoke coming from the bonnet of my vehicle. I turned off the engine and alighted the vehicle with all 3 of my passengers and report the matter back to our Ops Room. I had bruises on my hands and my right wrist was swollen. I also notice one of my passenger (Sufian) sitting at the rear seat was bleeding at his forehead. I did not observe any one from the bus injured. Subsequently ambulance came and my 3 passenger and I were conveyed to Ng Teng Fong Hospital, we were given medical leave as stated above.

Due to the impact, my SAF vehicle was badly damaged at the front and the front bumper was dented, front left headlight shattered, the bonnet cover was compressed and the front windscreen cracked. The bus was only dented at the rear portion. I wish to state that there is an in-car camera installed in my SAF vehicle.
