To whom it may concern

The abovementioned patient was seen for right hand and thumb pain for a period of 1 month after he had been involved in an RTA in June 2018. He was seen by me on 28 June 2018 with pain over the Rt hand and the right thumb. He had an xray done which did not show any fractures. He was treated with a thumb spica splint and did a mri on 12/6/2018. Mri showed sprain and low grade tear at the attachment of the abductor pollicis longus at the base of the 1st meta sprain of the dorsal ligament at the thumb carpometacarpal joint. He was discharged well.

Thanks

To insurance company,

The above named patient was first treated at Mount Elizabeth Novena Hospital Emergency Department on 11/6/2018. He had been in a road traffic accident on 7/6/2018 and presented with dizziness since the accident and abrasions on his right arm.

A CT scan of his head was offered which the patient deferred till the next day.

On 12/6/2018, the patient returned for a CT Head. The CT head was reported as normal. He also experienced mild pain when moving the fingers of his right hand then.

Diagnoses were:

- 1) Right arm abrasions
- 2) Head injury with dizziness
- 3) Right hand contusion

He was discharged and advised to return if symptoms do not improve.

Hence, we would like to clarify on the purpose of the indication of this item (foam walker).
