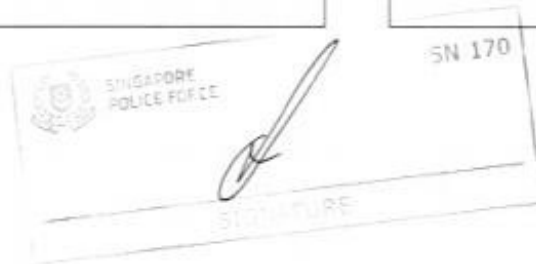

I went to the Bukit Timah Police Station yesterday and filed another report for insurance to claim against 3rd party, unknown as yet. The police reiterated that this is a matter for SICC to investigate since the incident happened in a private club with its own CCTV system which has captured already the image of suspect car.

Reverting to Jimmy's email of 5 June and on the assumption that it was a car belonging to a visitor, you can narrow down the search for the entry into the club of the suspect car, to 4.30-6.30pm (which was the time of my entry) of 29 May because if the car would have entered before 4.30pm or 2 hours before the incident, the suspect car would have been spotted by your security patrols being parked in a members carpark area. The much shorter time span for checking will allow security to resume checking without further delay since it will not hinder their daily routine jobs.

I look forward to hearing from you asap and thank you again for your assistance.

Attachment 1 shows an image taken by the CCTV camera of what could be the suspect's car in that it is white and quite clearly visible at the back, the fender detached from the impact hitting our car. Verbally, the security from the club think that the licence plate number reads "SKV3327D" but it is not clear. Also they have checked that such licence number does not belong to any member of the club i.e. it could have been a visitor which would explain their behaviour for not reporting the incident. You having seen the car, please tell whether is the same you saw at the incident scene?
