SKETCH PLAN





DESCRIBE CIRCUMSTANCES OF THE ACCIDENT



But the vehicle SJH 6332S stopped without proceeding ahead. So ~~that~~ I hit the vehicle from behind and the speed of my vehicle should be less than 5km.
