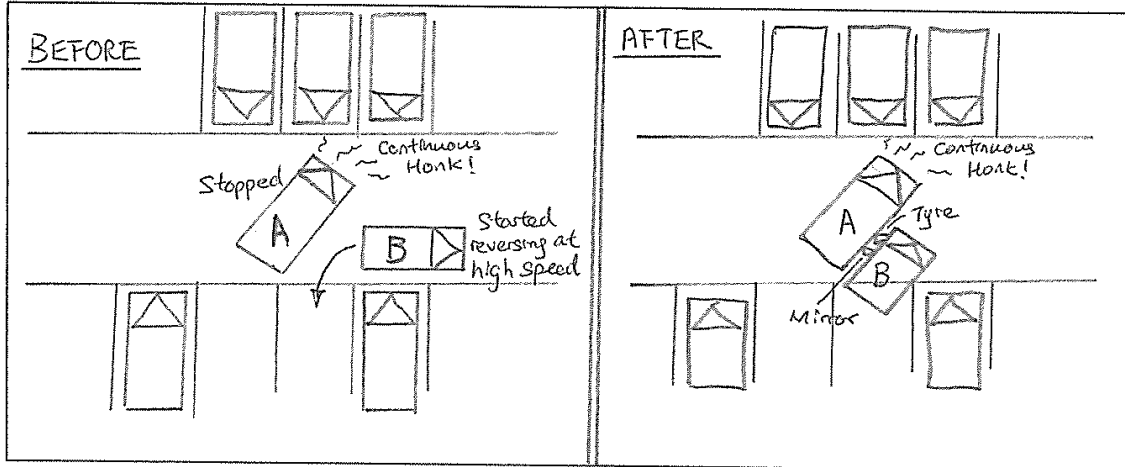

### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving my car out of the parking lot. When I was turning out, the lot on my right was empty and I also noticed that vehicle B was stationary. When I had turned out, but still at a 45° angle, I noticed Vehicle B started to reverse at a high speed. Immediately I stopped my car and pressed my horn continuously. The driver of Vehicle B did not stop. Vehicle B banged into my car with her front left tyre hitting and damaging my right passenger door. Her left front side-mirror also scratched my right passenger door. Notice that there was a child sitting on the lap of the front passenger. The sky was still bright, visibility was good. The weather was clear and dry. No one was injured in this accident.
