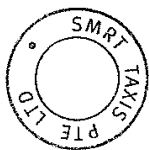

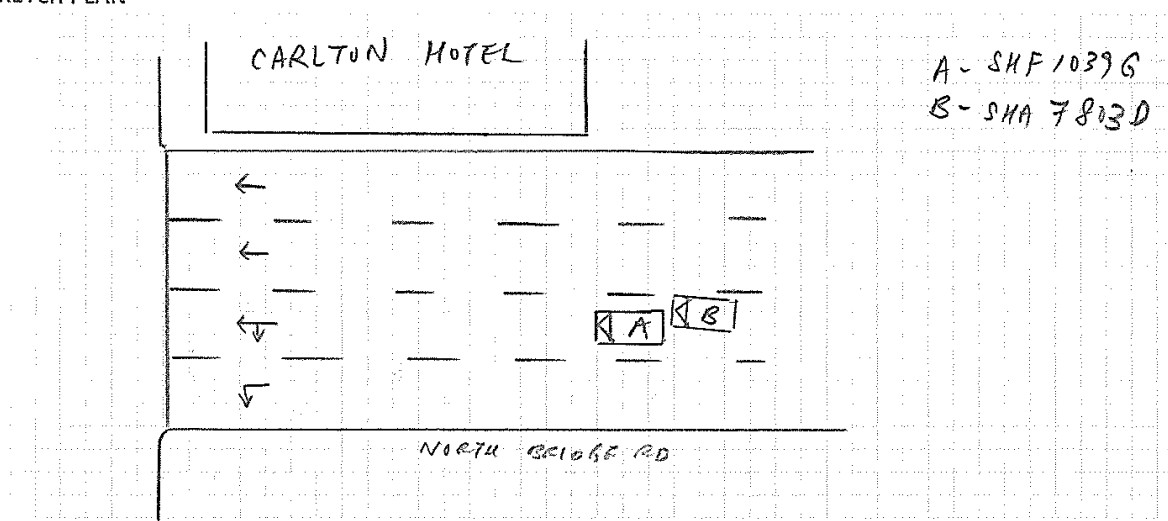

SKETCH PLAN

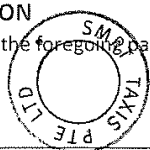
