## Brief Details.

On 25/05/2018 at about 1710hrs, I was driving my vehicle SFS6789Y a Black Nissan along the extreme right lane of Lornie Road heading towards the direction of Adam Road. The traffic was very heavy but the weather was clear and road surface was dry.

When my vehicle reaches the U-turn point near to lamp post number 74 and 76, I stopped my vehicle to look out for on coming traffic before I negotiate the turn. I stopped my vehicle for about 10 minutes before I make the U-turn. When I make sure that the traffic was clear and safe for me to make the U-turn, I start to inch out my vehicle to negotiate the turn but out of sudden a blue motorcycle dashed out and hit onto the left side mirror of my vehicle. The rider then skidded and fell onto the ground. I immediately applied emergency brake and I then stopped my vehicle before I got out of my vehicle to render assistance to him.

The rider condition was conscious but he complaint of pain on his chest and his left arm. I did not managed to help him to call for police or ambulance because coincidently I have forgotten to bring my mobile phone out with me today. I then seek a passerby assistance to call for ambulance.

Shortly after, the traffic police and the ambulance arrived at scene and the rider was conveyed to hospital by the ambulance. The traffic police then gave me a case card and advised me to lodge a traffic accident report vide incident E/20180525/0116.

I am not injured but I am unsure the actual injury of the rider and I also have no idea which hospital he was conveyed to.

My vehicle left side mirror was broken off and there are some scratches at the front left mud guard area. I saw the motorcycle front cover was broken. However, I am unsure what are the actual damages on the motorcycle.
