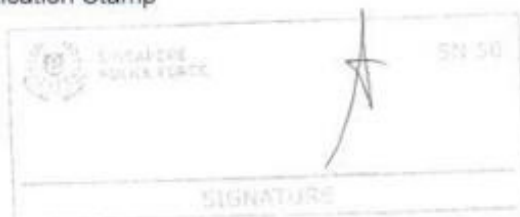

Then he had left the office with the rental vehicle.

On the 30th April 2018, the male client did not return the vehicle. Hence I messaged him and called him many times. However, he informed me that he still required the vehicle for work purpose. I still kept in contact with him with regards to the payments. However he last replied my message was on the 4th May 2018. I still tried messaging him till 11th May 2018, but there was no reply. My company then decided to repossess the vehicle. My company managed to track the vehicle to Blk 337 Tampines Street 32 carpark and we repossess the vehicle back ourselves.

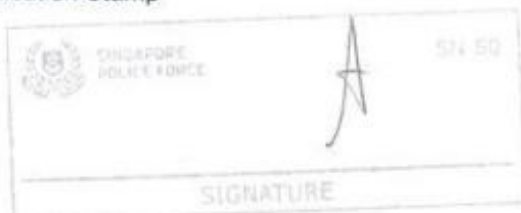


