

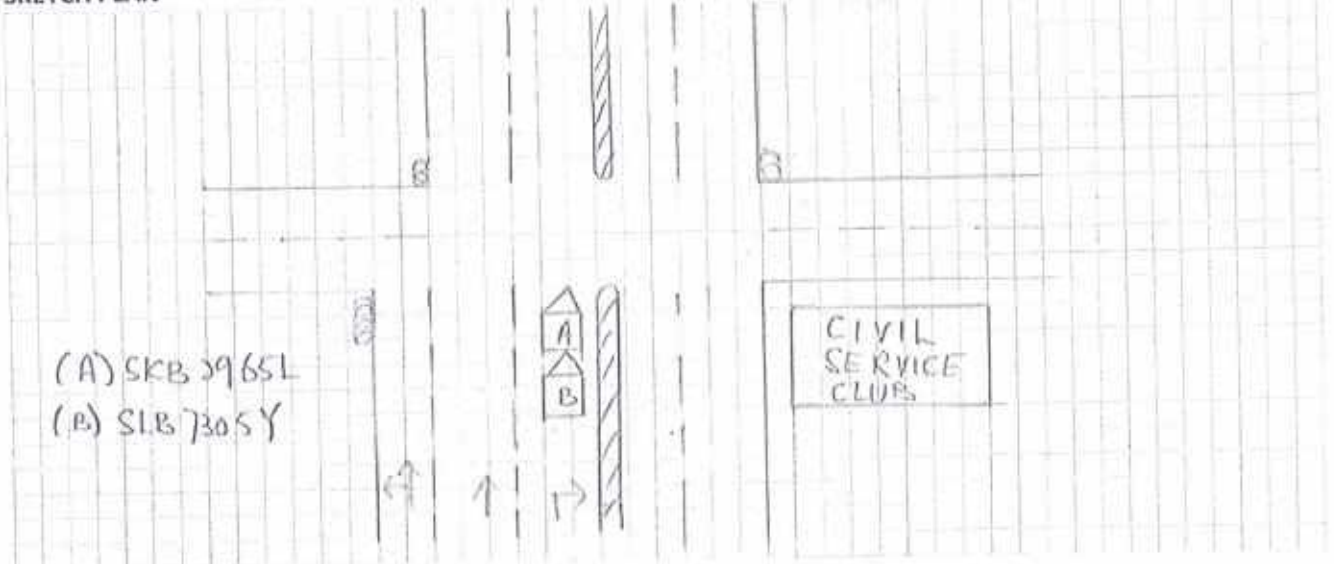

BUKIT BEROK WAST AVENUE 2 JUNCTION





