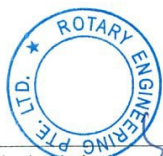
SKETCH PLAN

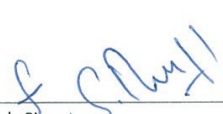

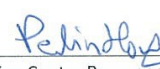

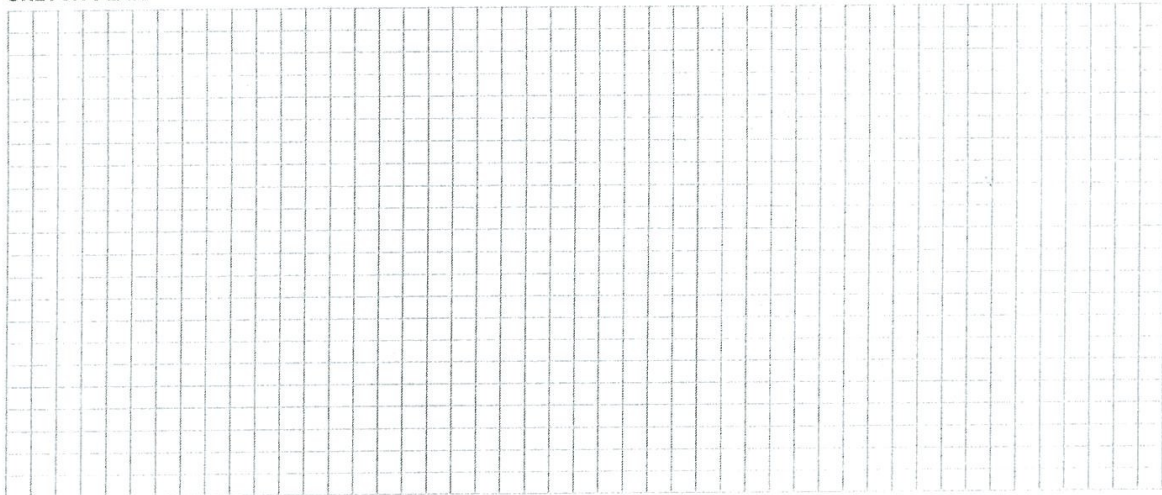

Hit the vehicle (SJR 6326H) right front corner when I after pick up the people. due to hit the vehicle blind spot and over confident myself no my vehicle there.

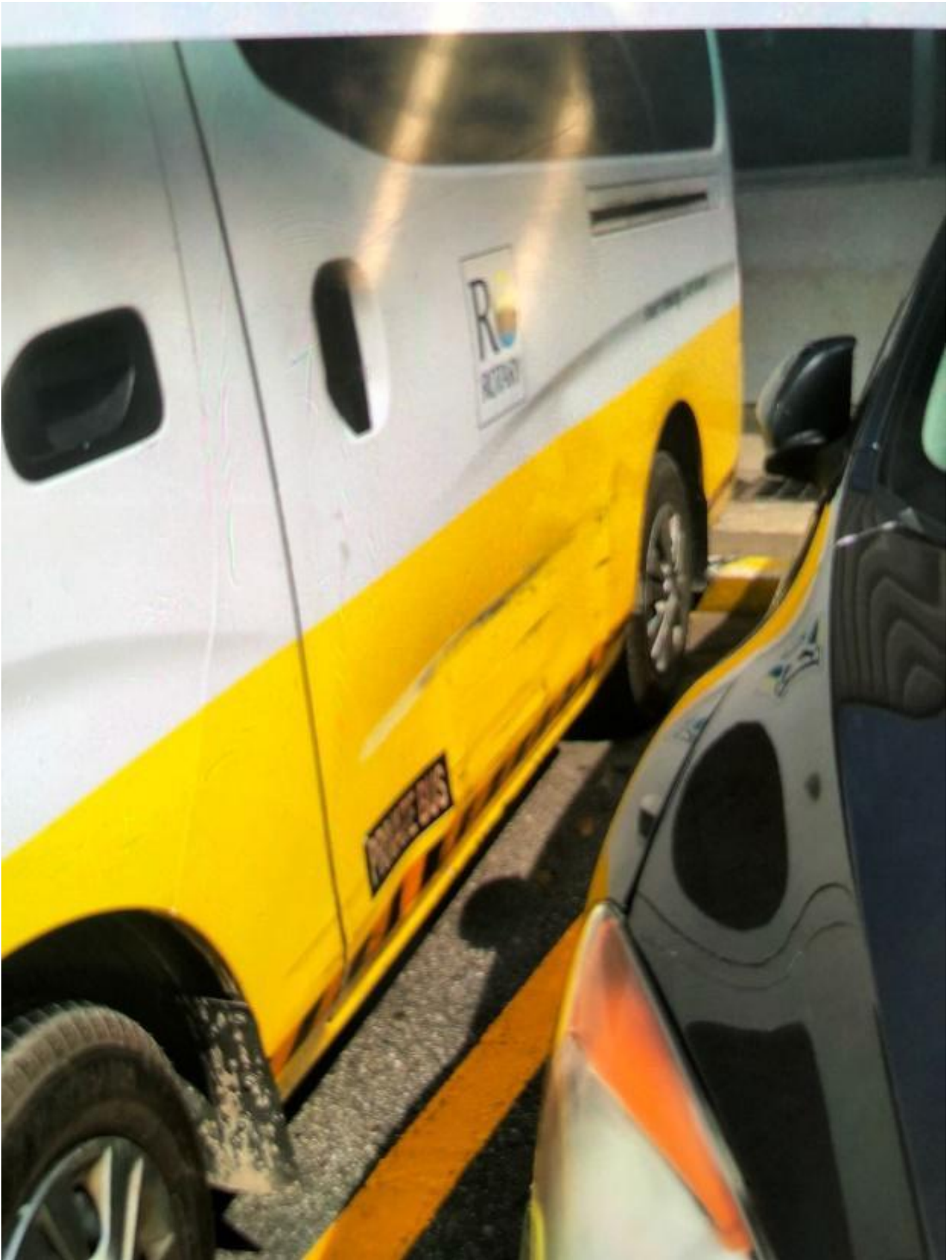

After I talk to driver (SJR 6326H) and his superior (Name don't know) and they said "No problem this is small ~~and~~ scratches. if anything we will contact you"

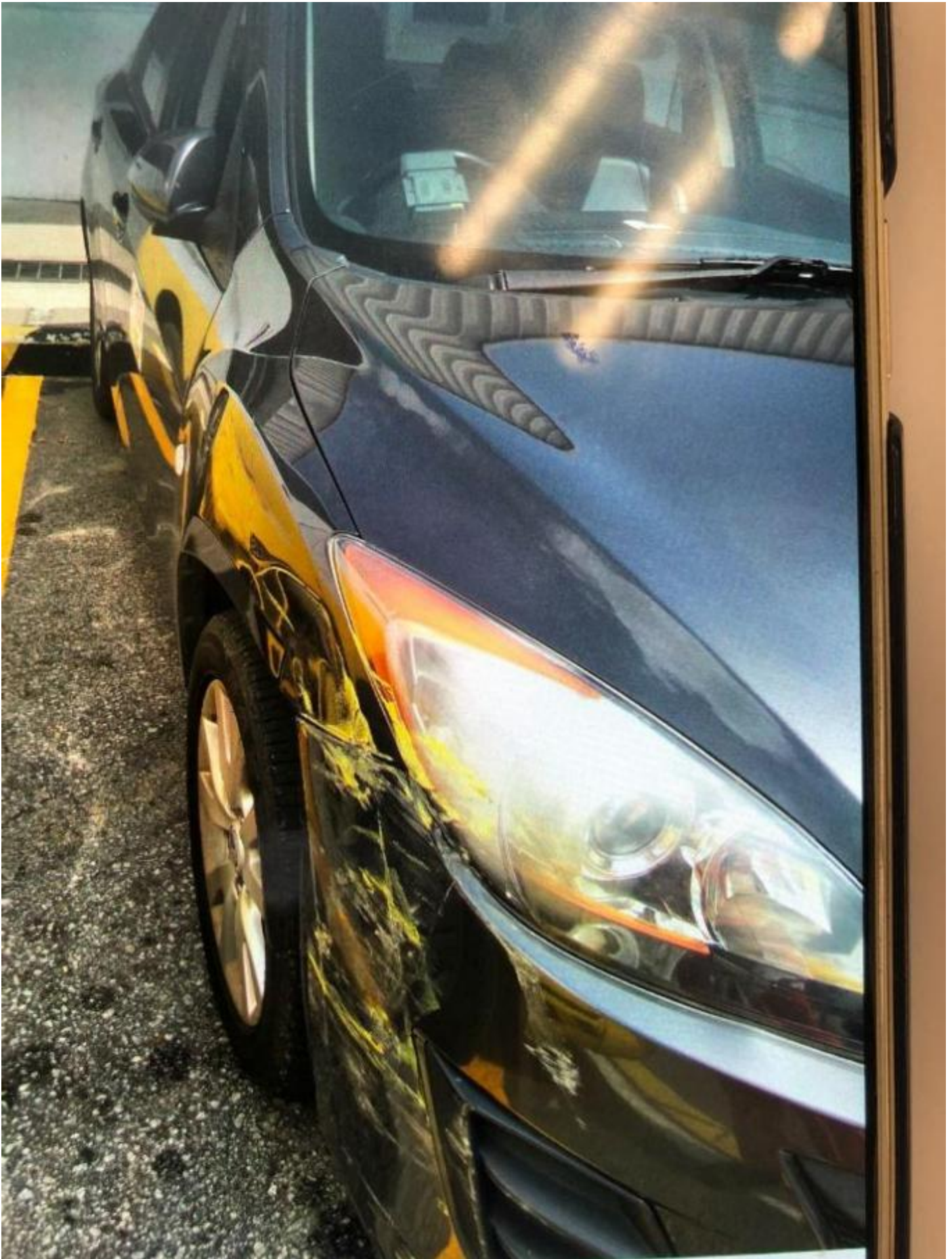
Then I take the my passenger van (PC 2468R) Come to my office.



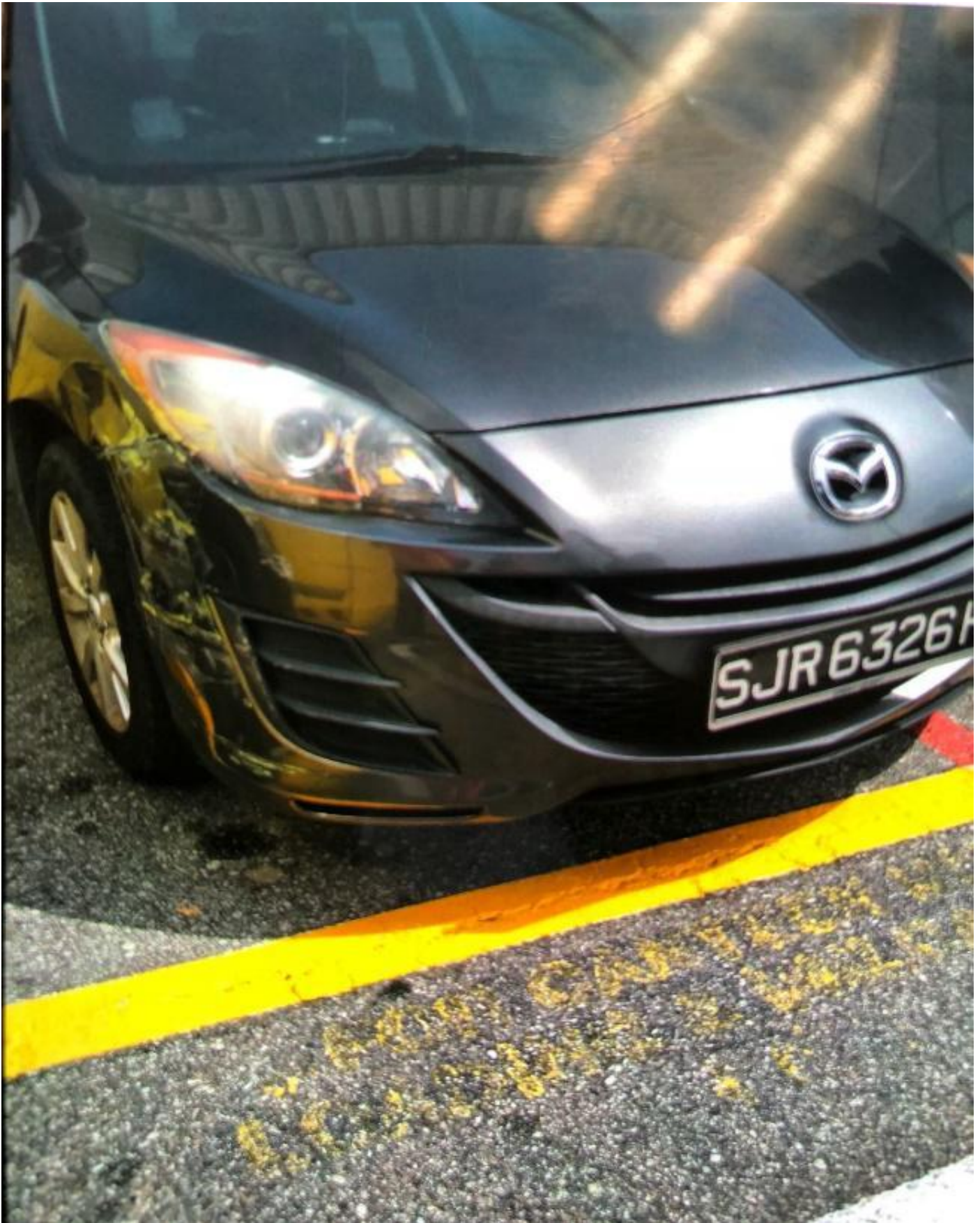
