Circumstances of Accident

28 May 2018, between 11:45pm to 12:05am, Jason Tow (S8214732B), driver of Mercedes E250 SLV2850S with 2 passengers, driving along Sims Ave East towards Chai Chee Ave on extreme right lane. Travelling at estimate 40-50km/hr, I proceeded to slow down as I need to make a right turn in estimate less than 25m towards Kembangan Lodge. Suddenly, I saw a car dashing out from Lor Mydin without stopping or any warning. Jeffery Sim (S7029533D), driver of Nissan Teana SJN2341K, fail to stop at stop line and proceed to dash out from Lor Mydin. Out of shock and in that very nick of time, I turn my steering wheel to my left to avoid hitting the Nissan. By my action, I wasn't sure my car either hit another on-coming car, Mercedes C200 SJU2929D, driver Madam Ong (S2020771Z) or was hit by Mercedes C200 SJU2929D. Resulting damage on my front left side. Madam Ong's car suffer damage on its right both doors. All 3 cars came to halt and stop along the kerb. An eye witness name Mr Raul (HP: 9640 4577) witness the cause of the accident. Then I realise the Nissan driver's front passenger seat, believing to be his wife was carrying a baby on her arm. No baby seat was found in the Nissan as required by Singapore Law. I suspect the baby without baby seat had distracted the driver's view and attention which may cause this accident. Mr Jeffery of Nissan Teana verbally asked me why I turn my car to my left. I explained to him should I not turn to my left, my car will crash into his front left door where his wife and baby were in. He admitted his reckless action and cause the accident and agreed to file claim against him. Traffic police and an ambulance were activated and arrive on scene shortly. No injuries were reported at that time. But one of the traffic police officer (rank sergeant) told me he gave a verbal warning to the Nissan's driver that baby seat is mandatory required. All involved drivers' exchanges particulars and drove off respectively.



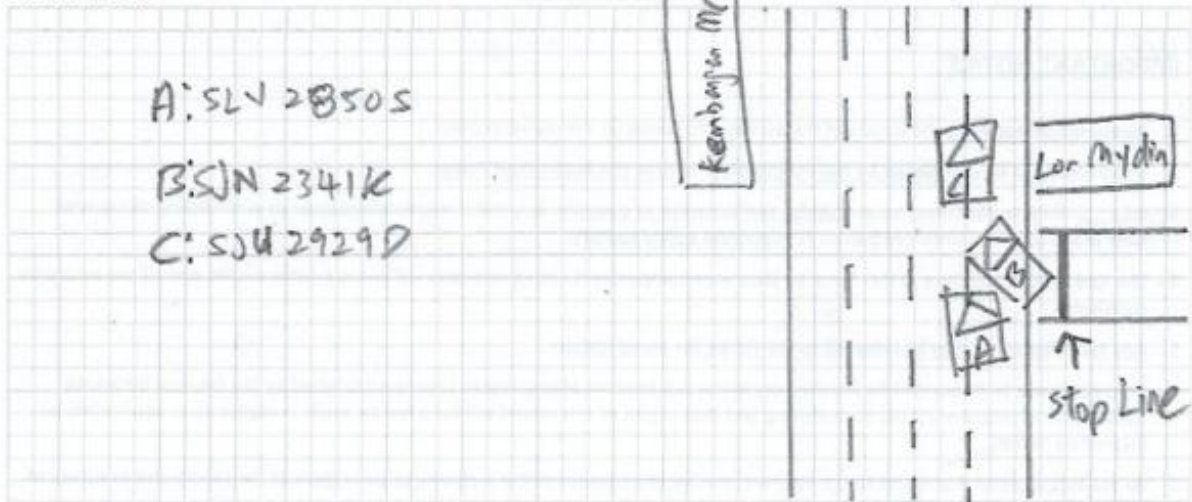

28 May 2018, between 11.45pm to 12.05am, Jason Tan (EP2473213), driver of Mercedes E250 SLV 28505 with 2 passengers, driving along Siong Ave East towards Chai Chee Ave in extreme right lane. Travelling at estimate 40-50km/hr, I proceed to slow down as I need to make a right turn in estimate less than 25m towards Kembangan Lodge.

Suddenly, I saw a car dashing out from Lor Mydin without stopping or any warning. Jeffery Sim (S7029533D), driver of Nissan Teana SJN 2341K, fail to stop at stop line and proceed to dash out from Lor Mydin. Out of shock and in that nick of time, I turned my steering wheel to my left to avoid hitting the Nissan. By my action, my car either hit another on-coming car, Mercedes C200 SUN 2929D, driver Madam Ong (S20207712) or was hit by Mercedes C200 SUN 2929D, resulting damage on my front left side. Madam Ong's car suffer damage on its right both doors.

All 3 cars came to halt and stop along the kerb. An eye witness name Mr Raul (HR: 9690 4572) witness the cause of the accident. Then I realise the Nissan driver's front passenger seat, believing to be his wife was carry a baby on her arm. No baby seat was found in the Nissan as required by Singapore Law. I suspect the baby without baby seat had distracted the driver's view and attention which may cause to this accident.



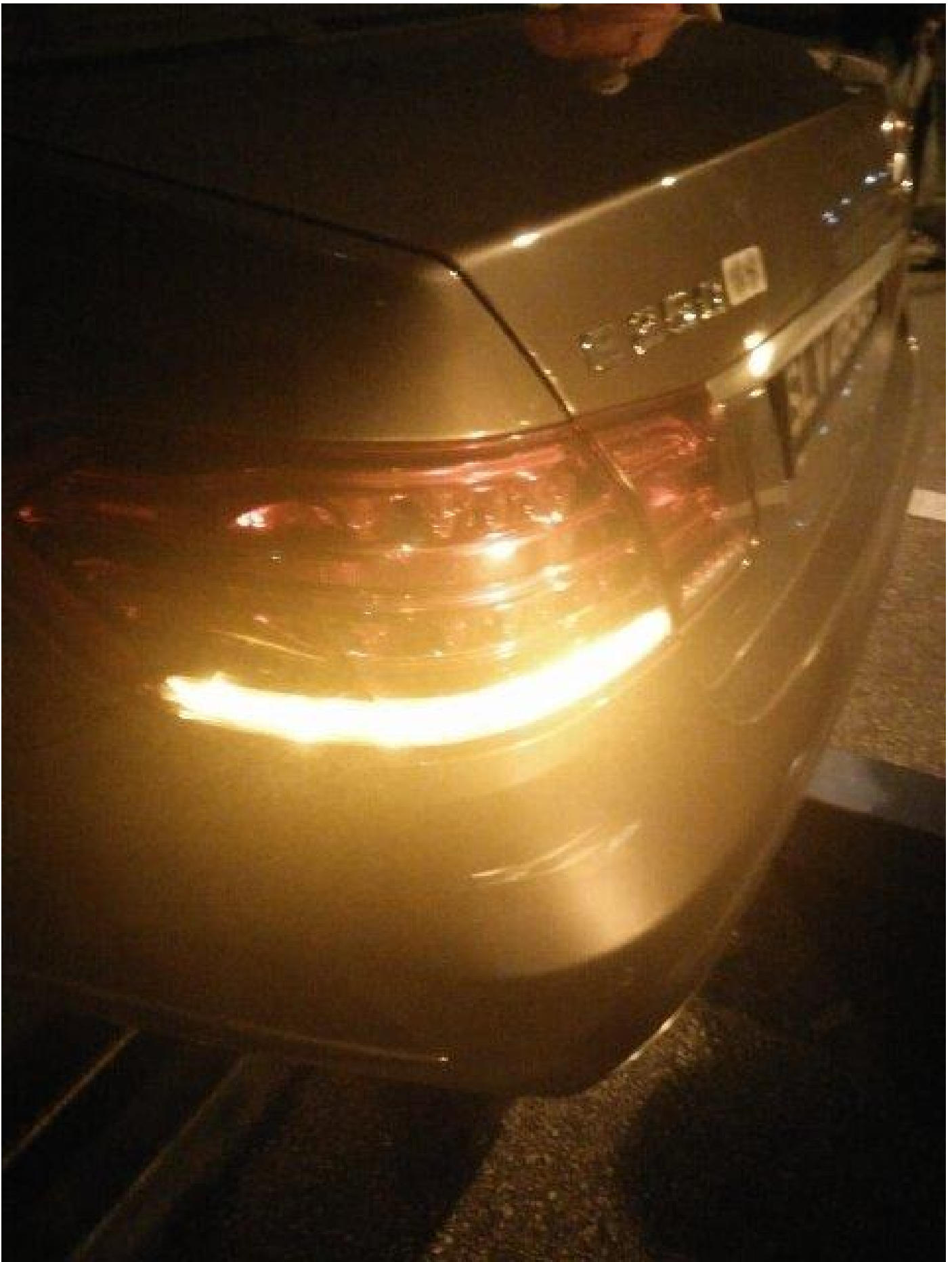

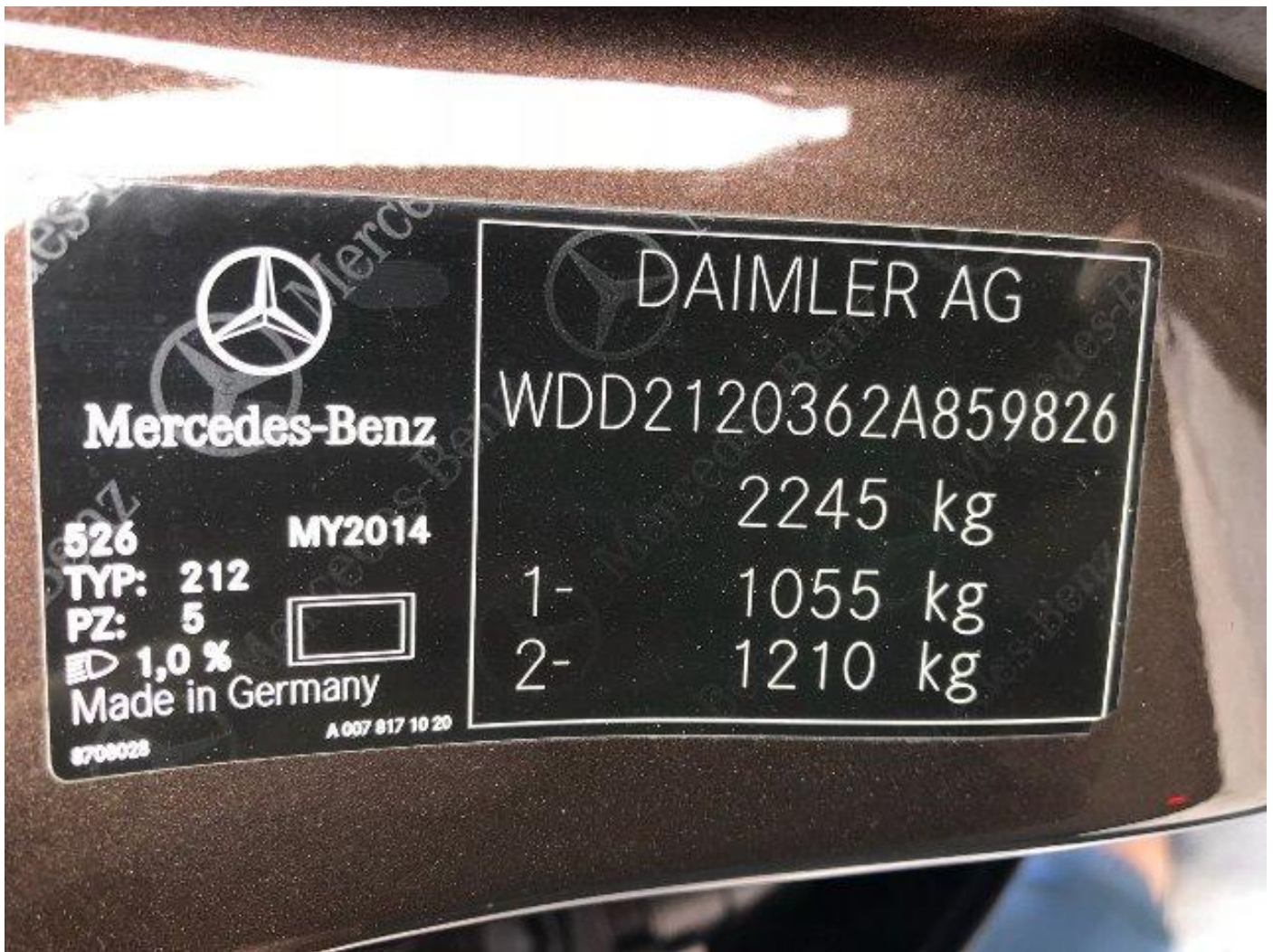
