

**Brief Details.**

On 19/06/2018, I returned home and my mother handed over a letter which was from the Traffic Police. The letter reference TP/IP/34961/2018 was address to my mother, Ngoh Ah Yeon on a alleged hit and run accident involving SKU2301C and FBM5848X along Ubi Ave 1 OSCP on 2 june 2018 at 2200hrs. My mother was the registered owner of the car,SKU2301C but the car was driven by my fiance, Lim Zheng Wei S9129534B Hp:91384473 and I.

I wish to state that on 02/06/2018, I drove the car in the morning until about 2000hrs. No one use the car during the alleged hit and run. I had spoken to IO Kaleswari Palani who advised me to lodge a traffic police report.

On the 02/06/2018 at about 1130hrs, I drove the car to B/302 Ubi Ave 1 open carpark and discovered the carpark was full. I make a three-point turn and the rear left of the car collided into a parked black motorcycle with P plate. Due to the impact, the bike landed sideway on the road. My fiance then came out and bring up the motorcycle with the help of a Bangladeshi and at the same time looking out for the owner of the bike. We made a check and there were no damage to the bike. My fiance took over the car and parked it at the front of the block and we went for lunch. At about 1200hrs, My fiance came to make a check but could not locate the owner. There was no damage to my car.


