## Circumstances of Accident

REFER TO POLICE REPORT NO:T/20180617/7004 LODGED AT Traffic Police Division HQ UBI. I am the driver of vehicle number SLR3881S. The following is my account of the accident between SLR3881S (myself, Silver Honda) and SCU1801C (driver Ms Katie Tan, Silver Mercedes) at the junction of Everton Road and Spottiswoode Park Road. This is also documented in two in-car cameras facing front and back of the front wind shield of SLR3881S. 1.I entered Spottiswoode Park Road from Neil Road at 12:21PM. My wife (Frederique Soh) was in the front passenger seat and my son (Rocco Loh) was in the rear passenger seat behind my wife. Upon approaching the junction of Everton Road and Spottiswoode Park Road, I noticed Ms Tan slowing down. As the road markings at the junction suggested I had the right of way, as well as seeing Ms Tan slow down, I proceeded across the junction. 2. While in the junction, Ms Tan disappeared from my peripheral vision and I did not suspect anything to be amiss. However, I was suddenly struck on the side of my door, immediately shattering the window. 3.I tried to apply brakes but my car rolled onto the curb and came to a stop upon hitting the pillar at a corner of the junction. I soon smelled exhaust and immediately turned off the engine. My wife, son and I were in a state of shock for the first few seconds. Then I realized my spectacles were missing and my wife offered me her spare glasses from the glove compartment, after which I noticed that my hand was bleeding. As my car door was blocked shut by Ms Tan's vehicle, I proceeded to climb over to the passenger seat to exit my car. The shattered glass had reached my passenger's door where my wife sat. My son had also exited the car. I sat on the curb with my wife and tended to the cut on my hand which was bleeding. Passers-by and residents responded quickly with tissue and first-aid kits. My wife and son did not appear to have sustained any immediate injuries. TO BE CONTINUED



Shortly after, an ambulance arrived, followed by a traffic police officer rider.
