(a) **Case IAFP-IB-20180312-Mechanical Inspection of Motor cycle, FBG7253E (TP/IP/16203/2018)**

On 11/03/2018 at about 8.23 am, the Deceased was riding motor cycle, FBG7253E along PIE towards the direction of Airport. Somewhere near to 18.8 km mark, while the Deceased was negotiating a right gradual bend, he lost control, mounted the left grass patch and collided onto the left guard rail. Due to the impact, the Deceased was flung over the railing and landed on the grass patch. The Deceased succumbed to his injuries and passed away at scene.
