c. Case IAFP-IB-20180420-Mechanical Inspection of Motor Bus, PC6045B (TP/IP/22369/2018)

On 10/04/2018 at about 6.45 am, the said motor bus (PC 6045 B) was travelling straight along Bishan Road towards Braddell Road, on lane 3 of 5 lanes road. At the signalized cross junction of Bishan Street 11, motor bus collided onto the left portion of a motor car that was travelling along Bishan Road towards Marymount Road, making a right turn into Bishan Street 11. The Deceased, who was a rear seat passenger of the motor car, suffered critical injuries, were conveyed to Tan Tock Seng Hospital via ambulance. On the same day at 8 am, the Deceased succumbed to his injuries and passed away at the hospital.

May I seek your assistance to perform a detailed mechanical inspection of the vehicle below:

- (a) Case IAFP-IB-20180420-Mechanical Inspection of Motor Car, SJM3610H (TP/IP/24215/2018)
- (b) Case IAFP-IB-20180420-Mechanical Inspection of Motor Taxi, SHB8858J (TP/IP/24215/2018)

On 19 April 2018 (Thursday) at about 7.27 p.m., the Deceased (A1) and 3 of her school mates (A2, A3 and A4) had boarded the Defendant's motor taxi from Clementi Mall and their intended destination was to NUS Campus (where they studied and stayed in Tembusu College). Video footage from B1 revealed that B1 was travelling along Commonwealth Avenue West towards the direction of Commonwealth Avenue on lane 1 of the 5-lanes road. Upon reaching the signalised cross junction of Commonwealth Avenue West X Clementi Road, traffic light colour for B1's direction was green only and B1 was seen making a right turn into Clementi Road. At this juncture, A5 was seen travelling straight along Commonwealth Avenue West towards the direction of Commonwealth Avenue on lane 4 of the 5-lanes road from B1's opposite direction when B1 made the intended right turn. As such, the frontal portion of A5 collided into the rear left portion of B1. Due to the accident, the Deceased was unconscious and suspected to have suffered a traumatic arrest. A2 was conscious and sustained multiple abrasions. A3 was conscious and complained of chest pain. A4 was conscious, complained of chest pain and back pain. B1 was conscious, complained of chest pain and back pain. A5 was conscious, sustained multiple abrasions and complained of chest pain. All 6 casualties were conveyed to National University Hospital (NUH) by ambulances.
