



The incident happened on 21 June 2018 around 13.25pm along Mount Elizabeth Link towards Bideford road outside Fraser Residence. At the point, the traffic light was RED and I tried to keep towards the right side of the road but my left-side mirror accidently brushed on the right-side mirror of taxi SHA2506U and my side mirror was retracted (pls refer to image as below).




I got out of my car to confirm if there are any scratches on the taxi side mirror, but the taxi driver demanded \$300 to repair his side mirror (to change the whole side mirror). As my mirror has retracted, there should not be any damages but his unreasonable man insisted that his mirror is cracked. I explained and clarified with him that there is **no** possibility that my mirror can knocked into his mirror to cause the crack. The line is blind spot assist line but he is very persistence that I need to compensate him \$300. Pls refer to below images of his mirror. There are no scratches on his right-side mirror.
