Circumstances of Accident

REFER TO POLICE REPORT : T/20180612/2085 LODGED AT MARINE PARADE N P C BRIEF DETAILS I AM LODING THIS REPORT ON BEHALF OF MY MOTHER (KENG BAN CHWEE OF NRIC NO: S0114111B OF HP NO: 90115300). ON 11/06/2018 AT ABOUT 1130HRS, MY MOTHER ARRIVED AT OCBC SECURITIES LOCATED AT 18 CHURCH STREET AND PARKED THE VEHICLE (ONE WHITE BMW WITH VEHICLE REGISTRATION NUMBER: SCN909U) AT THE 4TH FLOOR. AT ABOUT 1530HRS TO 1540HRS, MY MOTHER WENT BACK TO THE VEHICLE AND DISCOVERED THE DAMAGES. AS THE VEHICLE WAS STILL ABLE TO BE DRIVEN, MY MOTHER THEN DROVE HOME. THERE WAS NO NOTE LEFT ON THE VEHICLE. ON 12/06/2018 AT ABOUT 1200HRS, I REVIEWED THE RECORDING OF THE IN-CAR CAMERA AND DISCOVERED THAT AT ABOUT 1202HRS ON 11/06/2018, ONE VEHICLE WHICH WAS PARKED ON THE RIGHT SIDE HAD DRIVEN OUT OF THE LOT. IN THE PROCESS OF LEAVING THE LOT, THE CAR LEFT REAR PASSENGER DOOR HAD COLLIDED WITH THE FRONT RIGHT OF MY VEHICLE. FROM THE FOOTAGE, DAMAGES WAS ALSO SEEN ON THE REAR LEFT PASSENGER DOOR OF THE CAR WHICH WE BELIEVED TO BE A TOYOTA WITH REGISTRATION NUMBER SLG368K. THE SAID CAR THEN DROVE OFF WITHOUT STOPPING. MY VEHICLE SUSTAINED SCRATCHES ON FRONT RIGHT BUMPER AND PAINTWORKS. THERE IS ALSO THE POSSIBILITY OF THE SENSOR BEING DAMAGED. I AM NOT TOO SURE OF THE COST OF REPAIR. OUR PLAN AT THE MOMENT IS TO LEAVE THE DAMAGES ON OUR VEHICLES AS IT IS UNTIL THE CASE CONCLUDED. I HAVE THE RECORDINGS OF THE IN CAR CAMERA THAT CAPTURES THE INCIDENT.

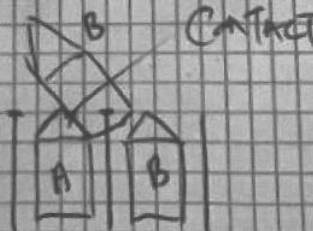

Brief Details.

I am lodging this report on behalf of my mother (Keng Ban Chwee of NRIC No: S0114111B of HP No: 90115300).

On 11/06/2018 at about 1130hrs, my mother arrived at OCBC Securities located at 18 Church Street and parked the vehicle (one White BMW with vehicle registration number: SCN909U) at the 4th floor.

At about 1530hrs to 1540hrs, my mother went back to the vehicle and discovered the damages. As the vehicle was still able to be driven, my mother then drove home. There was no note left on the vehicle.

On 12/06/2018 at about 1200hrs, I reviewed the recording of the in-car camera and discovered that at about 1202hrs on 11/06/2018, one vehicle which was parked on the right side had driven out of the lot. In the process of leaving the lot, the car left rear passenger door had collided with the front right of my vehicle. From the footage, damages was also seen on the rear left passenger door of the car which we believed to be a Toyota with registration number SLG368K. The said car then drove off without stopping.

My vehicle sustained scratches on front right bumper and paintworks. There is also the possibility of the sensor being damaged. I am not too sure of the cost of repair. Our plan at the moment is to leave the damages on our vehicle as it is until the case concluded.

I have the recordings of the in car camera that captures the incident.
