WARRANT TO ACT

I/we, Muhammad Effie Bin Temian, NRIC No. 58824257B, the owner of motor-vehicle no. FBT 5842C hereby appoint you, New Union Company, to act for me/us for the purpose of bringing and commencing an action for damages I/we have suffered as a result of the aforesaid accident.

I/We hereby authorise and empower you to act for me/us in this matter in negotiating a fair and reasonable settlement with the party/parties and/or with the insurer(s) concerned with regards to my claim for repair costs/policy excess, rental and or loss of use and other expenses incurred by me/us in consequence of this accident and upon settlement of this matter, to release all such settlement sum including loss of use or car rental fees (where applicable), surveyor's fees, police report/motor accident report fees, etc (if same have been so incurred by me/us) to me/us or to the party so authorised or nominated by me/us to receive such payments. You may proceed to apply to the relevant authorities, organisations or bodies to obtain all necessary reports or information arising from or in connection with the aforesaid accident as may be required by you. In the event that a settlement is not forthcoming or reached, upon confirmation by me/us to commence legal proceedings against the other party/parties for the recovery of damages due to me/us, I/We shall render all cooperation to attend at your office in person and/or to attend court whenever so requested.

Your legal costs on a solicitor and client basis will be as agreed by me/us and be paid to you as agreed or as may be determined upon taxation where applicable which sum shall be deducted from the settlement funds in your clients' account. These will not include any disbursements contributed by any third party. However should I/We fail or neglect to render all cooperation to you as a result of which legal costs is ordered against me/us by the Court, I/we shall be personally liable for the said costs and our disbursements.

I/We fully understand and irrevocably agree and authorise the third party's insurers to make payment of the settlement sum to New Union Company and for you to release all the balance of the settlement funds less your costs and disbursements, directly to me/us (where same were incurred by me/us) or to the party whom I/we have so authorised and I/we hereby absolve you and the third party's insurers of any and all liability during your/their course of following any/or all of my/our instructions.


