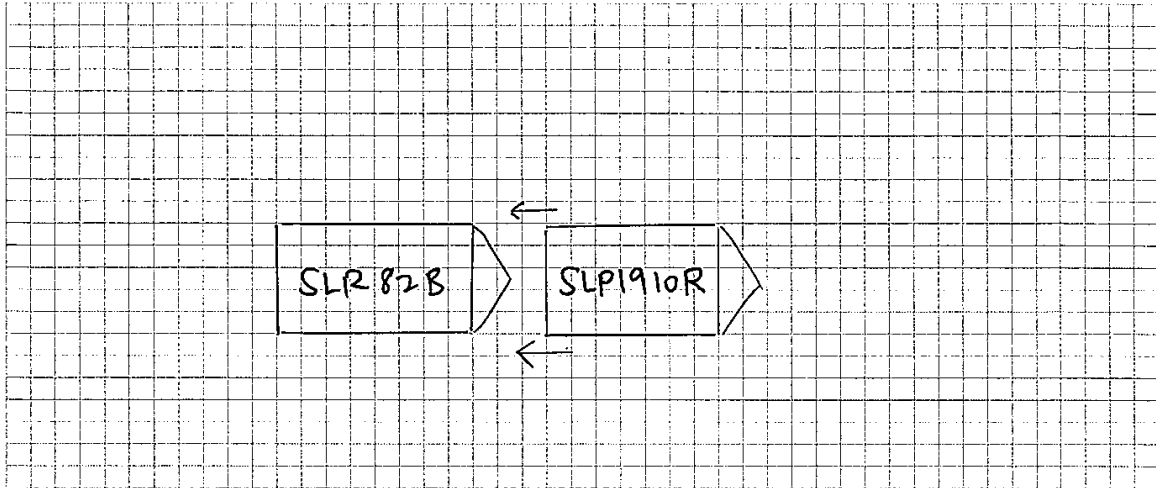

SKETCH PLAN

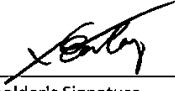
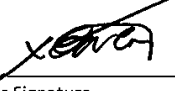
