SKETCH PLAN





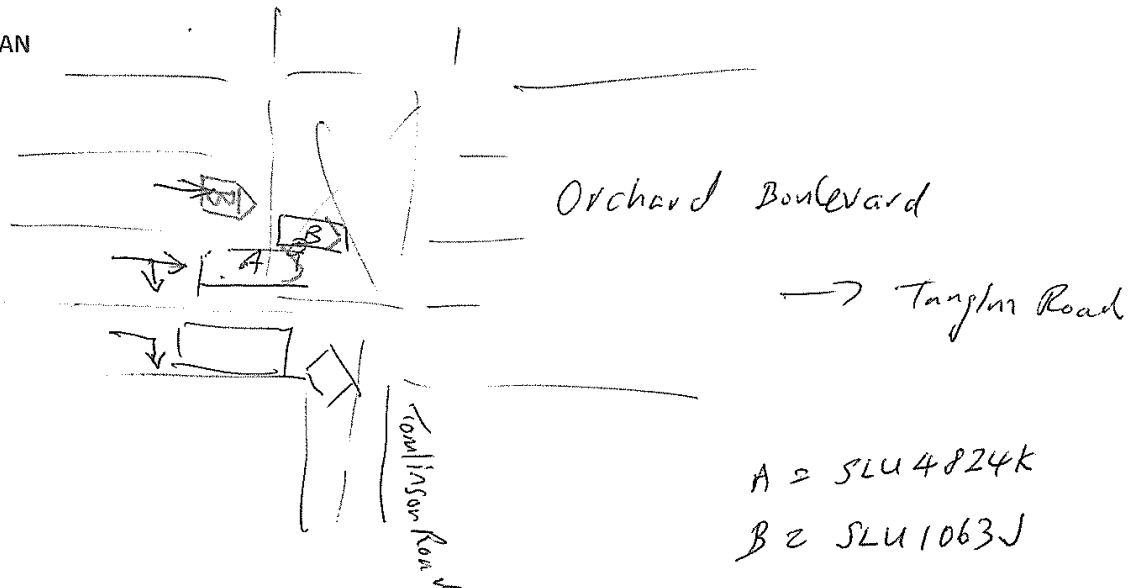

Traffic light turn green I move forward just two car length Car B SLU1063J cut in front of my car and side sweep my car on left side front fender and bumper in front of Left front wheel. This happen on 21 Jan 2018 10.38 am along Orchard Boulevard, junction with Tomlinson Road towards Tanjong Road. Car B SLU1063J fail to keep a distance and failure to check Right mirror before changing lane. This accident could have avoided if he CAR B SLU1063J has keep to his lane going straight. My car A SLU 4824K in car camera has proof that CAR B SLU1063J hit side sweep my car B. otherwise my car front left corner bumper will be damaged.

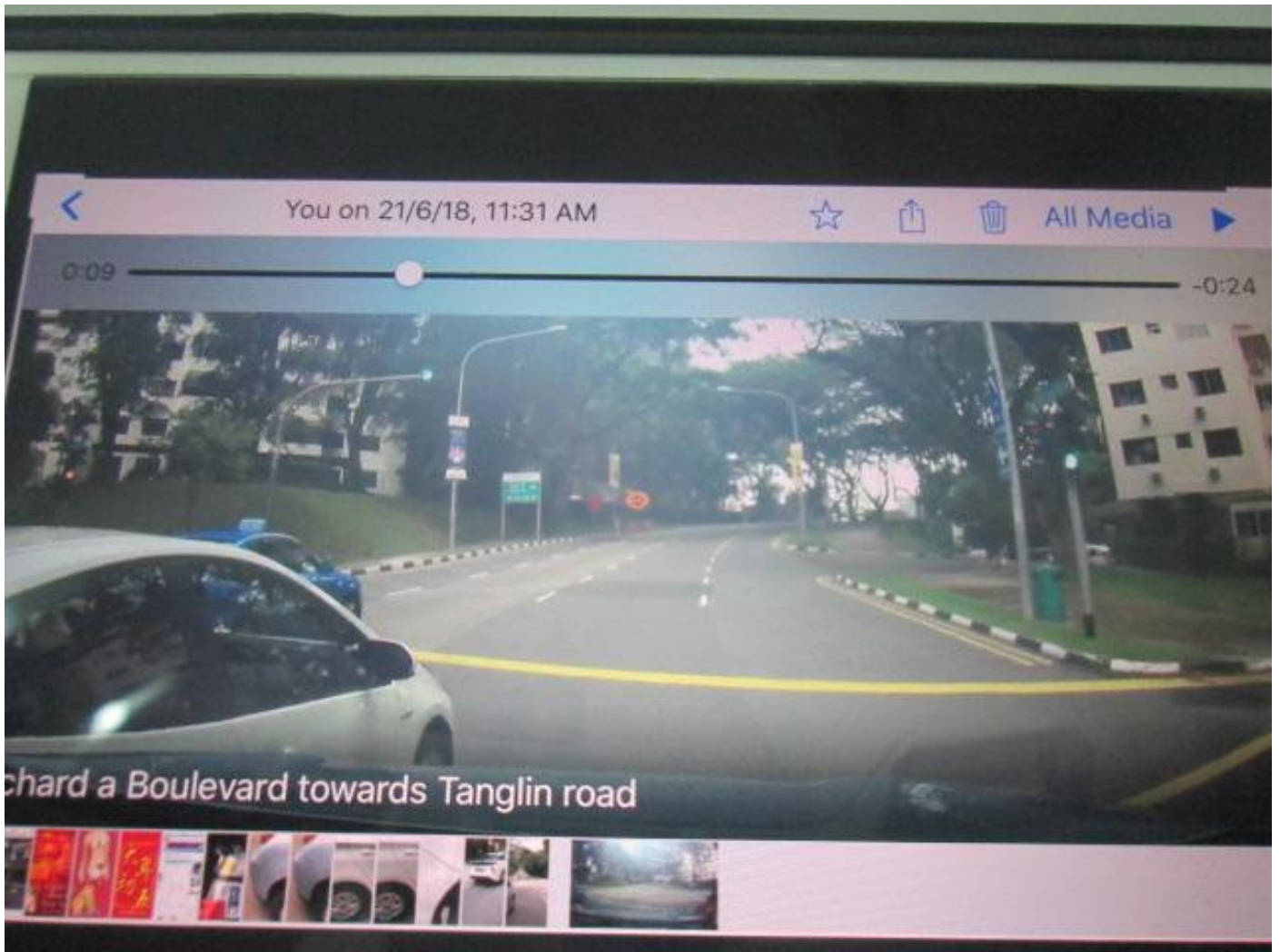
