Circumstances of Accident

I, Mr. Ng Hee Lok S8218406F was the driver for the vehicle SKM155M on 23 June 2018 @ around 3.30pm. The owner of the vehicle, Ms. Koh Keng Hwee S8138484C, was my spouse and she was not feeling well and so I was driving the vehicle home along with my 2 kids aged 9 and 11. Our vehicle was travelling along PIE toward Changi after an event @ SAFRA Jurong. While travelling along the PIE, the traffic was heavy but smooth flowing and our vehicle was travelling along 75km-80km at the second lane. Driving halfway, the vehicle (SLN35J) in front of us brakes and come to a stop, we had also brake and stop just behind the vehicle. After stopping seconds later, we felt a big impact coming from behind and causing our vehicle to move forward and the steering wheel airbag was activated. After which, the driver from the back vehicle (SLQ4390R) came to assist to open the driver door as it was jammed and upon conversation, the driver of vehicle SLQ4390R, Mr. Koi Aik Hiong S1180236B had admitted that he had failed to stop in time and causing the chain collision, involving 4 vehicles; 1 st vehicle, Malaysia registered Ford Ranger (JNF7657), 2nd vehicle, Singapore registered Audi (SLN35J), 3rd vehicle (our vehicle), Singapore registered Mitsubishi Lancer (SKM155M) and last vehicle, Singapore registered Toyota Prius (SLQ4390R). After exchanging the particular of the driver, as there was no injury involved, all the vehicles moved off and EMAS had towed our vehicle to the nearest carpark @ 2020 Bukit Batok Industrial Park A, waiting for our workshop tow truck. The above reported was to my best knowledge.

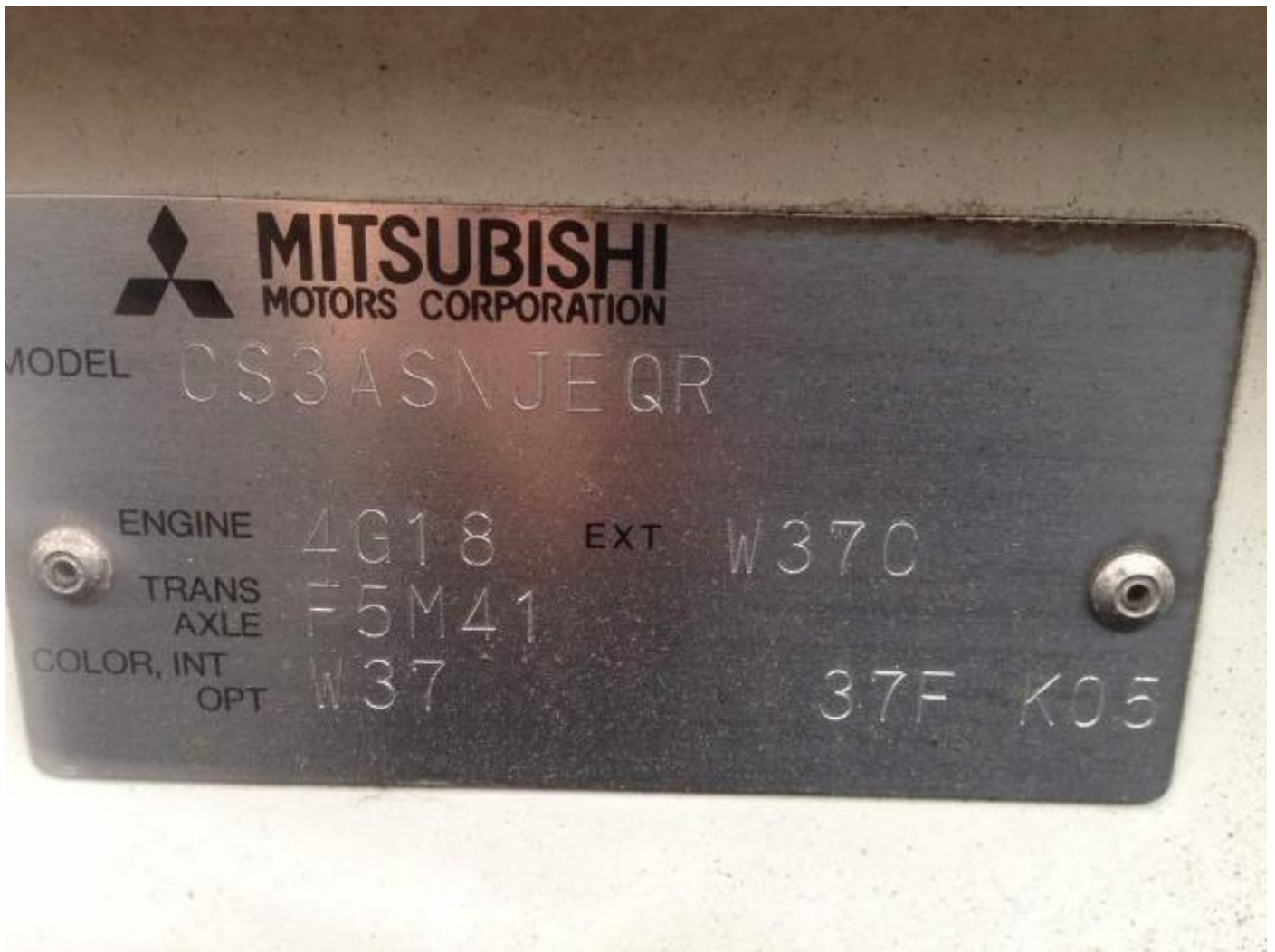

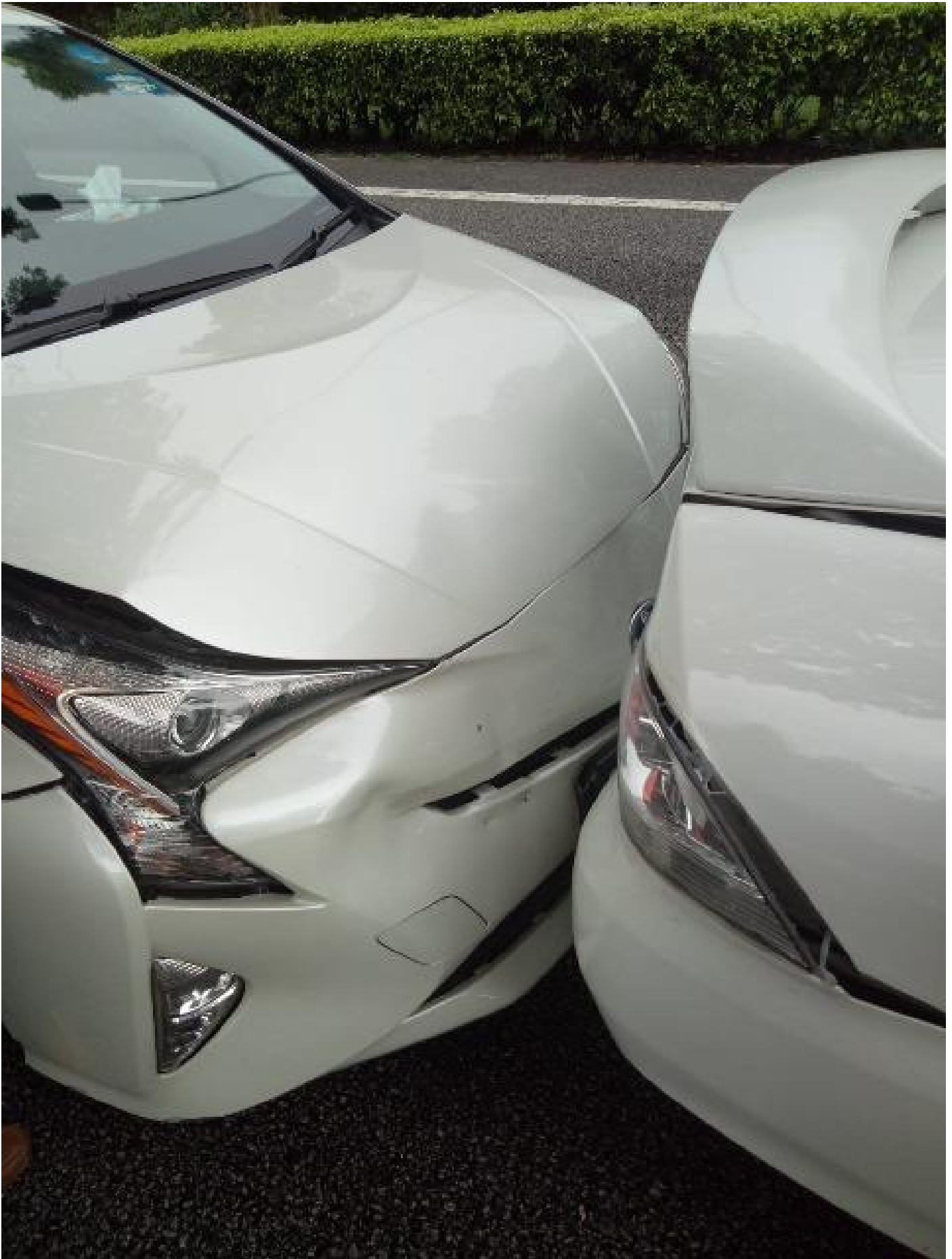
