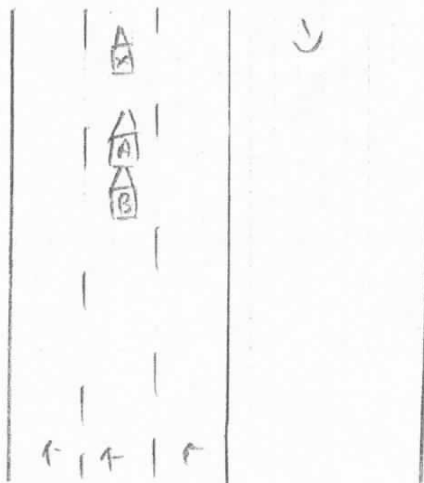
Sketch Plan #2 Pg. 1
