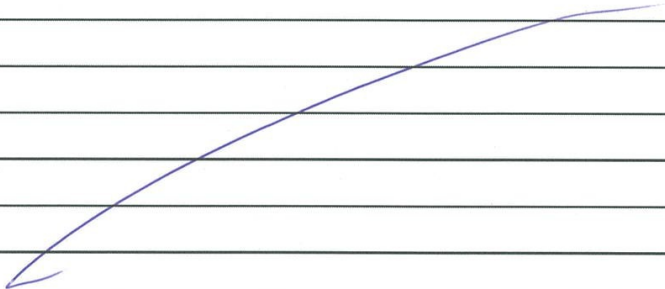

Describe Circumstance of the Accident.

ON 23/06/2018 @ 1000HRS, I PARKED MY TAXI (SHC 6216 U) IN AN OPEN CARPARK LOT @ ANG MO KIO AVE 8 (NEARBY BLK 509 & PARKING LOT #671).

AFTER I HAD LOCKED & SECURED MY TAXI, I THEN LEFT TOWARDS MY HOME.

WHEN I RETURNED @ 1310HRS, I THEN STARTED TO DRIVE OFF AWAY BUT SUDDENLY I HEARD SOME SOUND COMING FROM MY TAXI AND NOTICED A NOTE ON THE FRONT WINDSCREEN.

THE NOTE STATED – STATED THE CONTACT DETAILS OF THE DRIVER AS MR TAN AND HIS CONTACT NUMBER : 9784 6720.

BASED ON THE VIDEO FOOTAGE VIEWED, IT OCCURRED @ 1150HRS – 23/06/2018.

WHILE VEHICLE B (SKZ 424 T – MITSUBISHI / WHITE) WAS REVERSING INTO A PARKING LOT (HANDICAPP LOT – ON MY LEFT) THE REAR RIGHT OF VEHICLE B HAD COLLIDED ONTO THE FRONT LEFT PORTION OF MY TAXI.

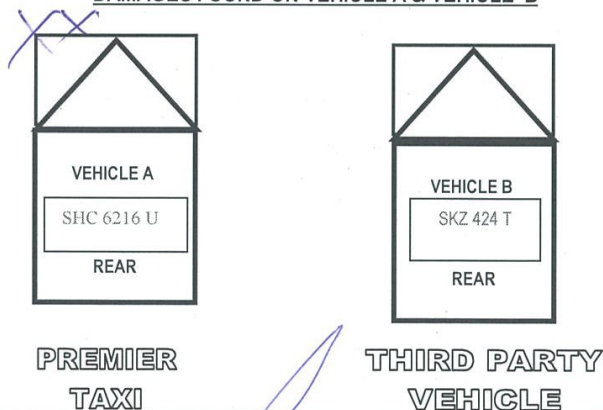
