Brief Details.

On 23/06/2018 at about 1205hrs, the Taxi(SHC5329J) that I had drove met with an accident at the T-junction between Henderson Road and turning right to Telok Blangah Heights. Prior to that, I was waiting at that said traffic light and there was another car in front of me. All of the sudden, another car (SJL3352H) hit the back of my Taxi. I managed to stop my taxi from hitting the car in front. Once stopped, both drivers wanted to exit out however as the traffic light had turned green, we did not want to hog the traffic. We drove to a nearby carpark and exchanged particulars.

My Taxi sustained scratches and dents at the rear bumper, causing some misalignment on the bumper and I am unsure of the damages to the other car. My Taxi does not have any in-car camera installed. Due to the impact, I felt a slight pain however I went home and got some rest. When I woke up, the pain worsen as such I went to Mount Alvernia Hospital for a medical check-up and received 7 days of MC. I am lodging this report to assist in any investigation necessary as well as to inform my Taxi Company of such matters.
