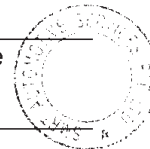


AUTHORIZATION TO ACT


