Refer to Police Report: T/20180625/2059 lodged at Toa Payoh N P C Brief Detail. On 22/06/2018 at about 1830hrs. I had parked my vehicle at the above mentioned carpark before I went for dinner nearby. This was the last time I had my vehicle intact. On the same day at about 1930hrs, I went to retrieve my vehicle and drove back home. I did not notice if there were any damage on the vehicle then. On 23/06/2018 at about 0840hrs, I was alerted by my helper that while washing my vehicle, she discovered some damages on the front bumper (right side) of my vehicle. I made a check and spotted some scratches and paint transfer in black. I review my in car camera and discovered that the night before at about 1924hrs when I had parked my vehicle at the above mentioned carpark, a vehicle (SLG551Y) that had parked head in into the vertical parking lot in front of my vehicle (unknown lot number), had reversed his vehicle out of the lot and was in close proximity to my vehicle. The footage did not exactly capture the collision however it showed the paint transfer on his vehicle after he drove off. When I continued viewing the footage, I realized that I was on my way home from Guillemard Road, the same vehicle had stopped in front of my vehicle before the traffic light. The vehicle's rear left bumper had shown some paint transfer which I believed was from my vehicle as a result of the collision. As such I suspect that the driver was the one who had caused the hit and run. I wish to state that there were no other vehicle that had came in close contact with my vehicle from the time I discovered my vehicle was intact to the time my helper discovered the damages. I had made a check with Mercedes company and the minimum cost of damage to my vehicle is more than S\$1000 SGD. I am lodging this report for insurance claim purposes.

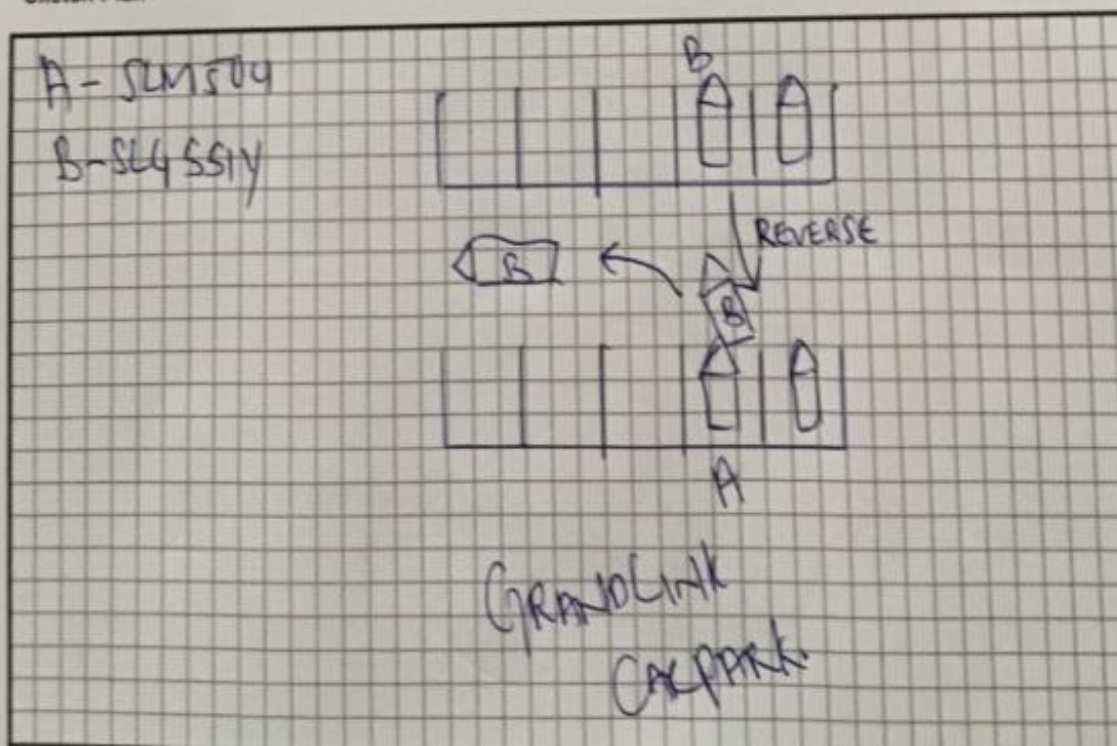

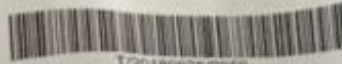
