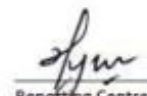
I understand, acknowledge, agree and consent that:

 - (ii) for complying with requirements under any regulations, laws or court orders.



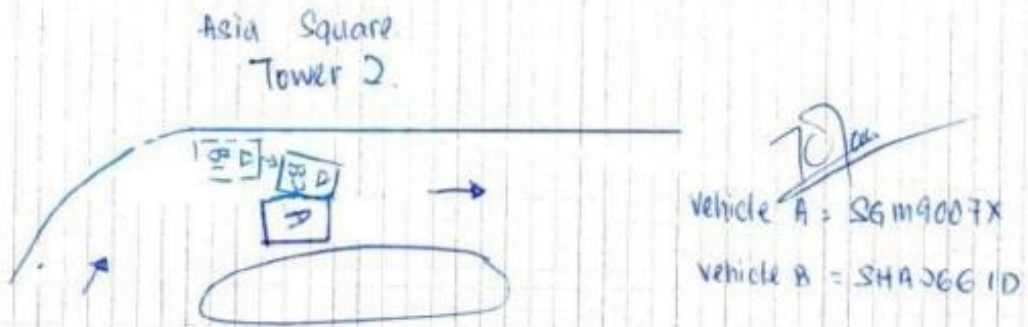
