
SKETCH PLAN

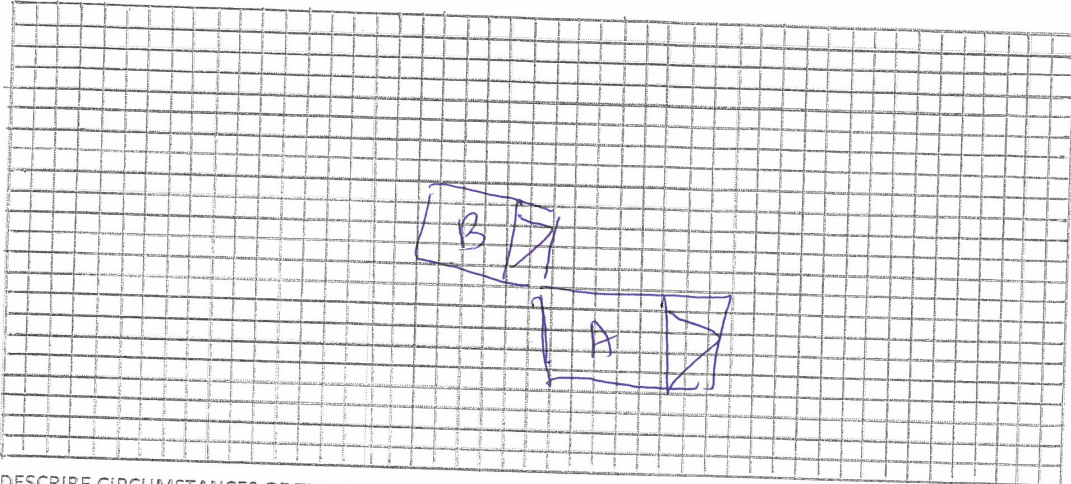
