Hi,

Attached please find photographs of the accident.

I want to say that I have been a safe driver. On that day of the accident, the driver of car SKH5343E that I banged against was indecisive, sped to cross the junction when the traffic light had just turned amber, giving me an impression that he wants to move off but did an emergency brake instead when his car was already more than halfway across the halt line of the junction. As the road was wet, even though I was quite a distance away, my car just couldn't stop timely to avoid the accident. I must mention also that I had recently serviced my car just 2 weeks ago and the brake pads were changed, but it didn't help. And even Mr. Goh Yew Boon driver of SKH 5343E admitted that he wanted to drive off but he thought there was red light camera, changed his mind and did an emergency brake to avoid being penalised.

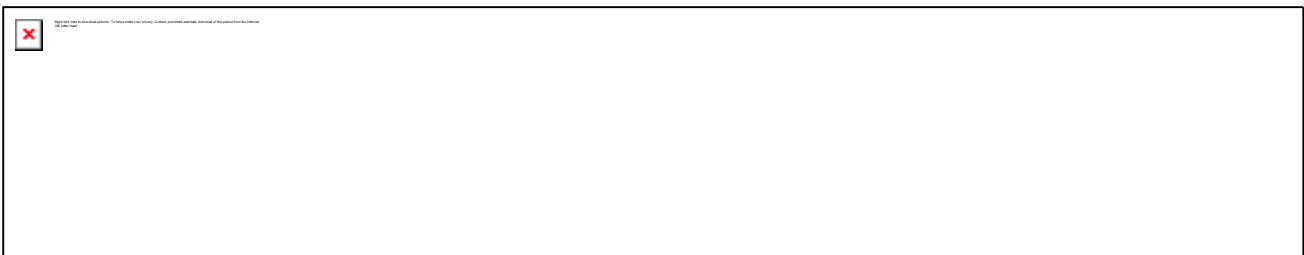
Hope this may help in the investigation.

- Statement and/or police report from independent witness(es) (if any)
- If you or your passenger(s) are filing a claim against any of the involved Third Party(s), you are to keep us informed of your legal representative(s) and the status of the claim

To protect your interest(s) in the handling of this claim, please do not discuss liability with any of the Third Party(s) and/or their legal representatives, or make any compromise or settlement without AIG's prior knowledge and consent.
