I WAS STATIONARY ALONG SERANGOON CENTRAL (NEX SC) TOWARDS TAXI STAND INFRONT OF THE YELLOW BOX WAITING FOR THE FRONT TRANSCAB TAXI TO MOVE. AT THE SAME TIME I HAD TO GIVE WAY TO THE BUSES THAT WERE COMING OUT FROM THE BUS STOP ON MY LEFT. AS SUCH WHEN THE TRANSCAB MOVED INTO THE TAXI STAND, I PROCEEDED TO MOVE TOO. SUDDENLY A VEHICLE SLD619C WHICH WAS TRAVELLING ON MY RIGHT CUT SHARPLY INTO THE YELLOW BOX AND COLLIDED ONTO THE RIGHT FRONT PORTION OF MY TAXI.

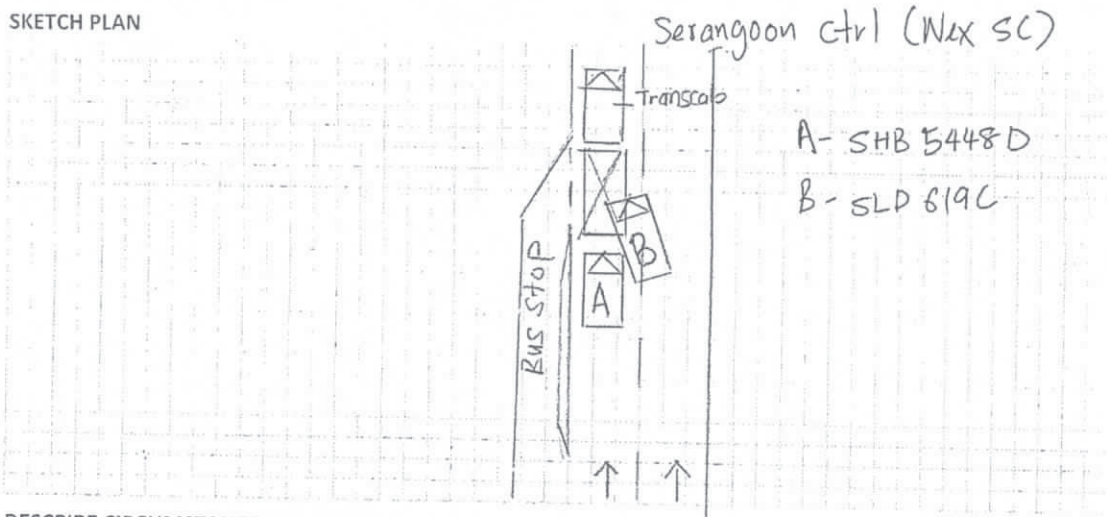
