We refer to the above matter.

It was reported that Insured vehicle had collided to the parked TP vehicle.

We had spoken to the Insured Driver and was informed of the TP claim. A letter was also sent out to the Insured company to notify TP claim and NCD issues. No feedback received till date.

In view of the above, we are of the view that liability is not to our Insured's favour and the damages sustained to TP vehicle were consistent to the nature of the accident.

As such, under MCF, liability is not to our Insured's favour and we have to settle the claim from the TP vehicle.
