



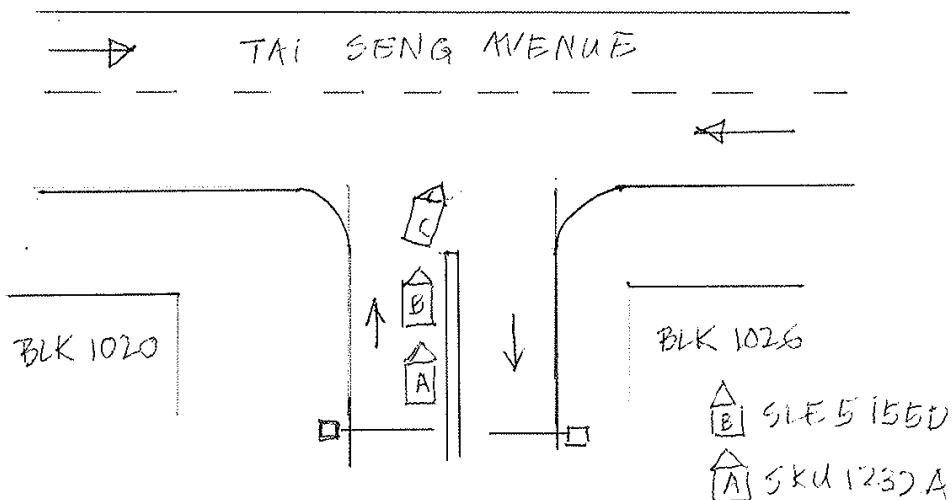

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT



My car was stationary when the Black Honda Vezel (SKU 1232A) hit the rear of my car out of a sudden.



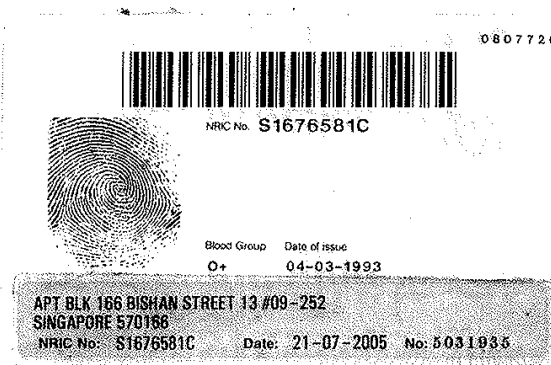
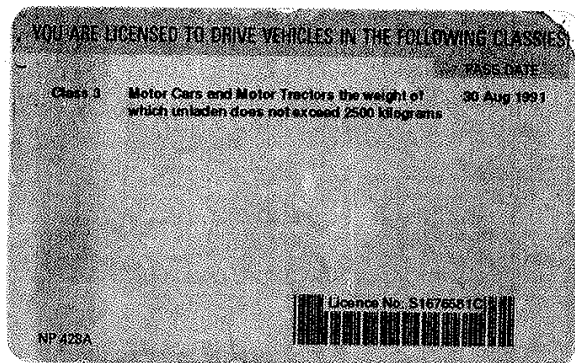
