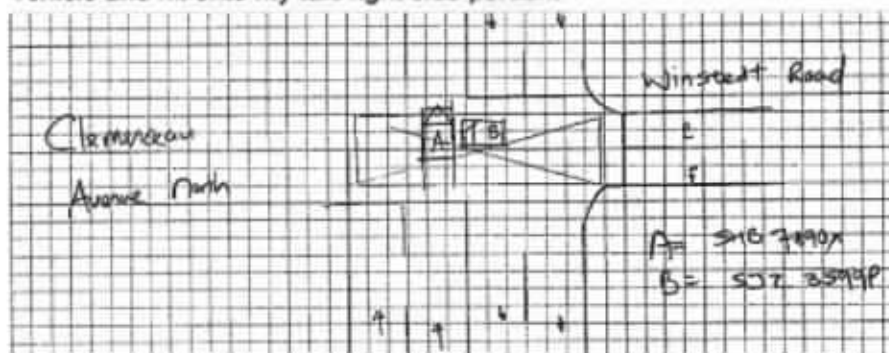

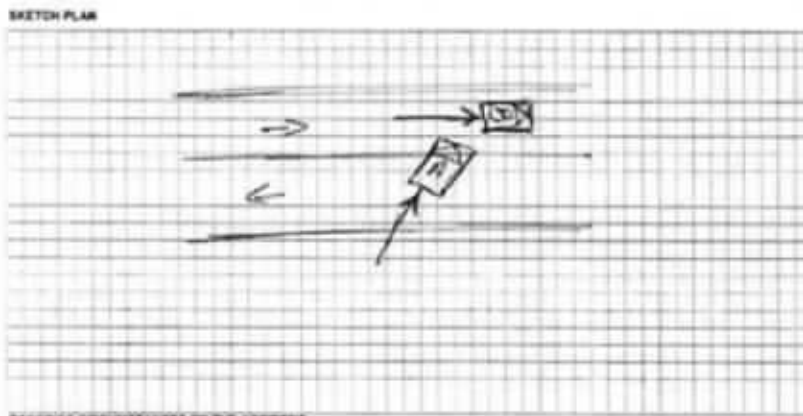

**ROAD TRAFFIC ACCIDENT INVOLVING VEHICLE NOS. SJZ 3599P AND SHB 7890X ALONG CLEMENCEAU AVENUE NORTH ON 29/06/2018**

We refer to the above matter.

Please be informed that basing on the accident statements submitted by both party, the liability is unclear for the above mentioned case. There is no conclusive evidence yet to substantiate either party's version. Below is a copy of our insured's accident report statement for your perusal.

**Brief Details.**

On 29/06/2018 at about 1345hrs after fetching my grandsons aged 9 and 12 years old and another granddaughter aged 10 already inside the car, I drove off along Winstead Road. I made a right turn towards Clemenceau Avenue North, subsequently a taxi came from the left side. I then pressed the brakes and managed to stop in time before a collision happened. There was a distance between my car and the taxi. I then alighted from the car and was approached by the taxi driver. Taxi driver was unhappy that I almost hit the taxi but there was no collision. The taxi driver then asked for my particulars and I gave my particulars but did not take down his particulars because there was no accident that happened. The driver then said nothing happened and thus went off. Inside the taxi there was a lady and boy as passengers. I then drove off and went home. Subsequently my taxi driver then called me and asked for money from me for the damages to the taxi. I was surprised of the demand since there was no accident earlier. I then told the taxi driver to drive over the taxi to my daughter's address located at 26 Bukit Batok East Ave 2 Hillview Regency. Subsequently the taxi driver came over and I took photos of the taxi and there was no damages to the taxi. I then told the taxi driver since there is no damages, I will not be paying him. I also told the taxi driver if he wants, he can lodge a police report. The taxi driver then became unhappy of the matter and left. On 05/07/2018, I received a letter from AIG insurance company which states that I was required to lodge a GiA report with the insurance and I did so. On 03/08/2018 I received a letter from traffic police reference: TP/IP/43585/2018 which states that I was required to lodge a traffic accident report. On 07/08/2018, I then received a lawyer's letter on behalf of the AIG Asia Pacific Insurance Pte Ltd which was demanding for a claim for the taxi driver. The letter has attachment of the taxi driver's medical certificate and his traffic police accident report.

I wish to state that when the incident happened there was no collision between the car and taxi. My grandchildren which were with me at the point of time can be witness to the incident and they would be able to say that there was no accident.

We are in a course of investigating into the circumstances of the accident. After verifying further with our OI we will revert with our opinion on the cause of the accident. Kindly do not refer to any party for legal assistance until you heard further from us.

Meanwhile, we would like to request the **CCTV footage / accident scene photos / evidence** in order to seek further instruction from our principal.
