REFER TO POLICE REPORT - T/20180628/2064 On 27/06/2018 at about 1345hrs, I was driving one SMRT taxi SHB1305J along Changi Road. It was a five lane road and I was on the right most lane. While I was driving straight at an estimated speed of about 50km/h and approaching the cross junction of Changi Road and Kembangan Road, I had observed that there was a car SGH7222E on the third lane. The car had suddenly paused in his lane (third lane) and as I was driving, he suddenly made a sharp right turn from the third lane to go into Kembangan Road and hit me while I was driving on the first lane. The car's driver side door then hit onto my taxi's front right corner causing a hard impact. I then quickly swerved my taxi to avoid more damage and as a result, my taxi had mounted the kerb of Kembangan Road. Traffic police had attended to the accident and I was advised to see a doctor. I had suffered sprains across my neck to the left side of my shoulder and arms. I also feel minor pain on my right shoulder and back. I went to make a check at Mount Alvernia Hospital and was issued with five days of medical leave. My taxi was towed back by SMRT. There is a dash cam in my taxi.

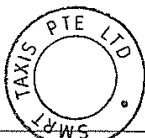

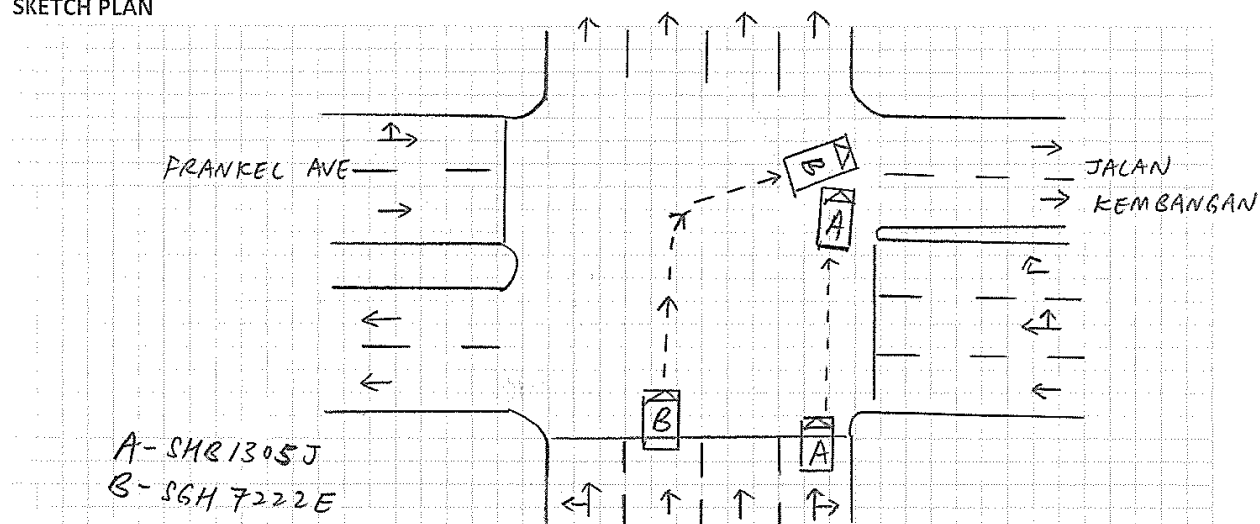

SKETCH PLAN



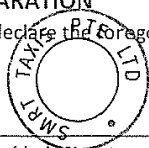
