Circumstances of Accident

ON 30 JUNE 2018, AT AROUND 2.15PM, I WAS SENDING MY HELPER TO CHANGI INTERNATIONAL AIRPORT TERMINAL 4 AND WAS DRIVING ALONG PIE TOWARDS CHANGI INTERNATIONAL AIRPORT. I WAS DRIVING IN THE EXTREME RIGHT LANE AND I WAS KEEPING TO THE SPEED LIMIT OF 80KMPH AND WAS KEEPING A SAFE DISTANCE FROM THE CAR IN FRONT OF ME. I HAD PASSED THE EXIT TO PUNGGOL AND WAS DRIVING PAST THE BEDOK AREA WHEN I NOTICED THE CAR (VEHICLE NO. SLQ6461G) IN FRONT OF ME SUDDENLY BRAKING TO STOP. I IMMEDIATELY APPLIED BY BRAKES TO STOP ALSO. I WAS ABLE TO STOP IN TIME AND I DID NOT COLLIDE INTO THE CAR IN FRONT OF ME. PLEASE CONTINUE ON THE ATTACHED STATEMENT.

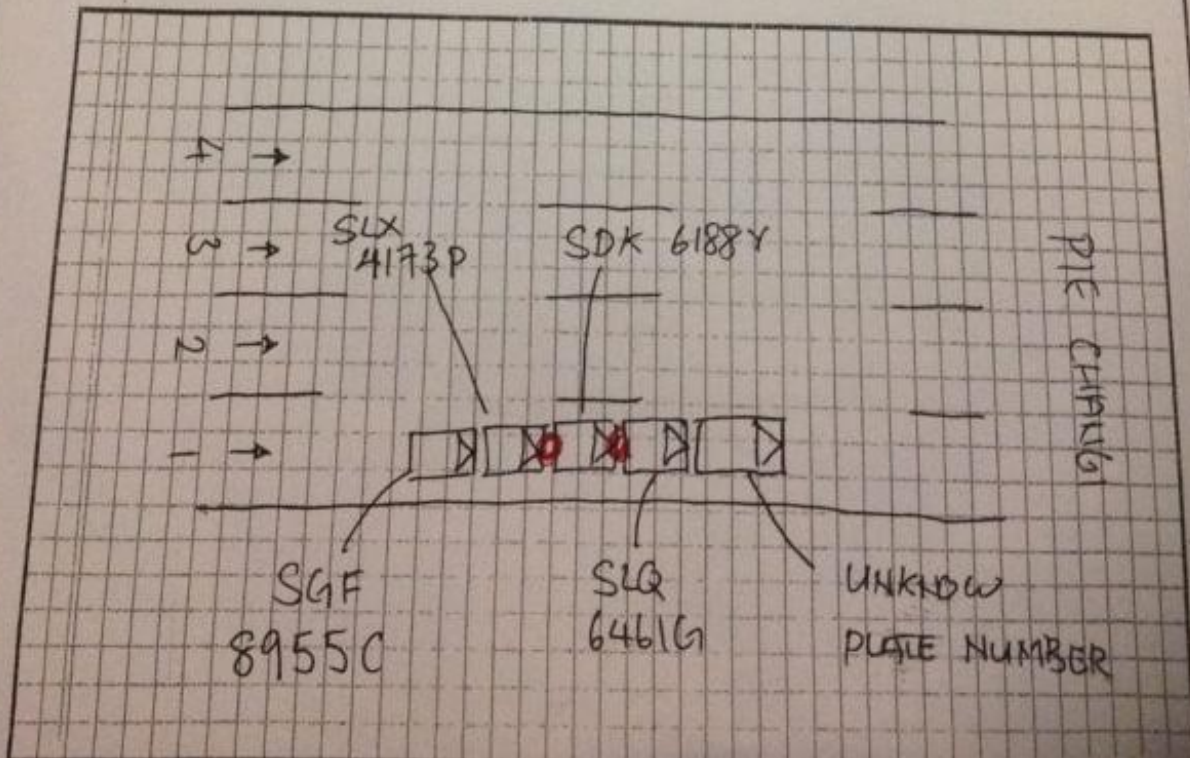

Accident Report involving Vehicle No. SDK6188Y

On 30 June 2018, at around 2.15pm, I was sending my helper to Changi International Airport Terminal 4 and was driving along PIE towards Changi International Airport. I was driving in the extreme right lane and I was keeping to the speed limit of 80kmph and was keeping a safe distance from the car in front of me. I had passed the exit to Punggol and was driving past the Bedok area when I noticed the car (Vehicle No. SLQ6461G) in front of me suddenly braking to stop. I immediately applied by brakes to stop also. I was able to stop in time and I did not collide into the car in front of me.

But in the next moment there was a crash into the back of my car as the car behind me (Vehicle No. SLX4173P) had collided into the back of my car. The impact of Vehicle No. SLX 4173P colliding into the back of my car caused my car to be propelled forward, thereby causing my car to collide into the back of Vehicle No. SLQ6461G in front of me.

I then got out of my car, as did the passenger of the car in front of me (Vehicle No. SLQ6461G) and the driver of the car behind me (SLX4173P). I first exchanged contact details with the driver of Vehicle SLX4173P. I then went to speak to the passenger of Vehicle No. SLQ6461G and I told him I had in fact stopped in time and that it was the impact of the collision of Vehicle No. SLX4173P into the back of my car that caused my car to move forward and collide into his car, (Vehicle No. SLQ6461G). I then went on to take pictures of the registration plates of both Vehicles Nos. SLX4173P and SLQ6461G. After that I went back to the passenger of Vehicle SLQ6461G intending to exchange contact details with him but he pointed me to the lady driver of the car who had by now come out of the car. Her name is Bernie Ng and **she told me she knows I had stopped in time and that there is an in-car-camera in her car, Vehicle No. SLQ6461G.**

After a bit more of discussion, Vehicle No. SLQ6461G decided to leave, and I left too, as I had to get my helper to the airport Terminal 4 for her flight.

I wish to state that there was another car that had stopped in front of Vehicle No. SLQ6461G, and also another car, Vehicle No. SGF8955C, that had collided into the car behind me (Vehicle SLX4173P). I was not able to take down the registration number of the very first vehicle because he had driven off after a short discussion with the passenger of Vehicle No. SLQ6461G.

I also want to state that at that time, there was another accident that had occurred in the center lanes just ahead of where all our cars had stopped.


