**DESCRIBE CIRCUMSTANCES OF THE ACCIDENT**

My car SL460267 was at the traffic junction of Sims Way and Geyland Road towards the traffic direction of Nicoll Highway, waiting for the traffic light to turn green. In front of my car were some cars and on my right lane was empty space. My car was on the 3rd lane of a 5 lane Sims Way. Upon noticing the empty space on my right which was the 4th lane, I decided to signal and turn right. Suddenly the Honda SL3983A <sup>left</sup> ~~slipped~~ into the 4th lane from the 5th lane and side swiped my right side rear door and right rear wheel as well as the right rear bumper. The Honda only sustained minor damage to its Front Left Bumper. The accident happened on 1st July 2018 at about 9:07 pm.

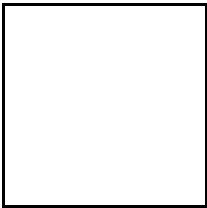
