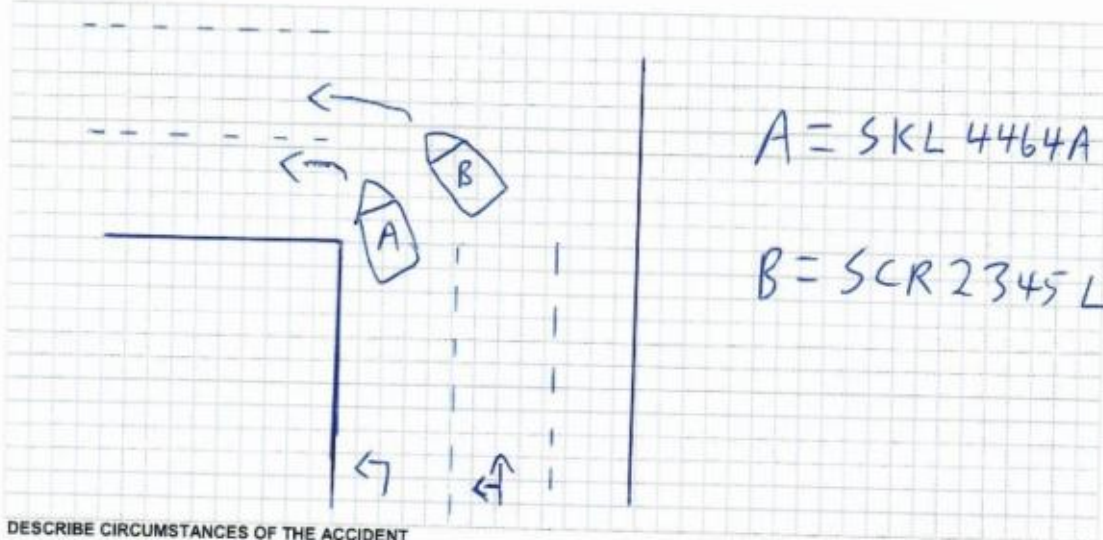

Report of Motor Car Accident on July 1 2018 at 7.30pm

Between my car SKL-4465L and SCR-2345L (dirver Ng Kok Chor – IC No. S0192241)

Junction of Marine Crescent and Marine Terrace Traffic Light

It was around 7.30pm on July 1, 2018 evening I (driver of SKL4464A) Tan Geok Lan was with passengers, my sister ~~Tan Geok Lee~~ ^{*Lydia Tan*} and a friend Bernadette Mah who stay in Block 20 and Block 5 Marine Terrace respectively. It was drizzling and I was sending both my passengers home. I was driving in the inner lane of Marine Crescent for left turn into Marine Terrace and when the light turned green, I started making the slow left turn when vehicle SCR-2345L rammed into my right side. I could not open my right driver's door to get out to inspect and had to ask the driver of SCR-2345L to drive forward so that I can straighten my vehicle to make a small reversal in order to get out of my car.

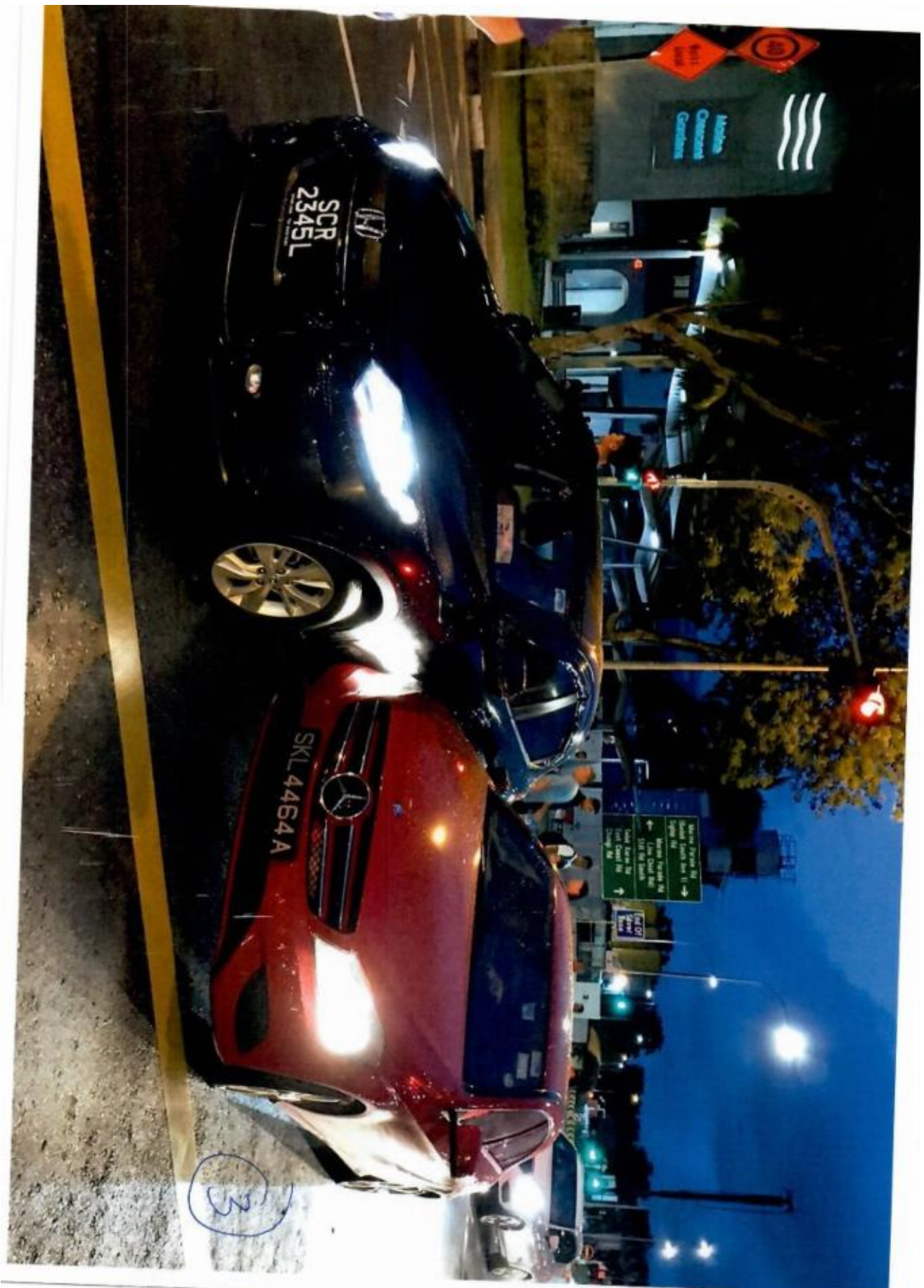




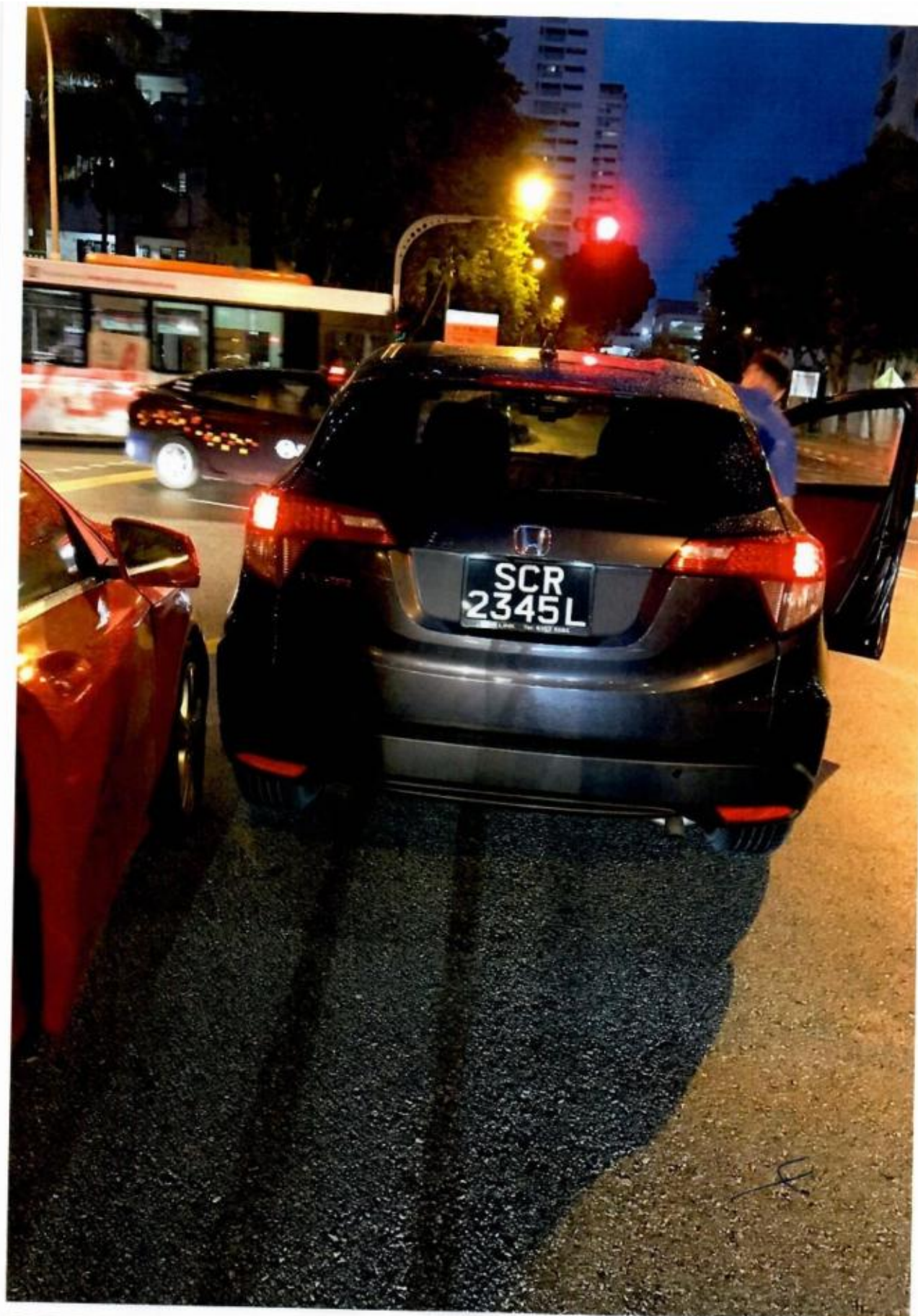
Accident Sketch Plan



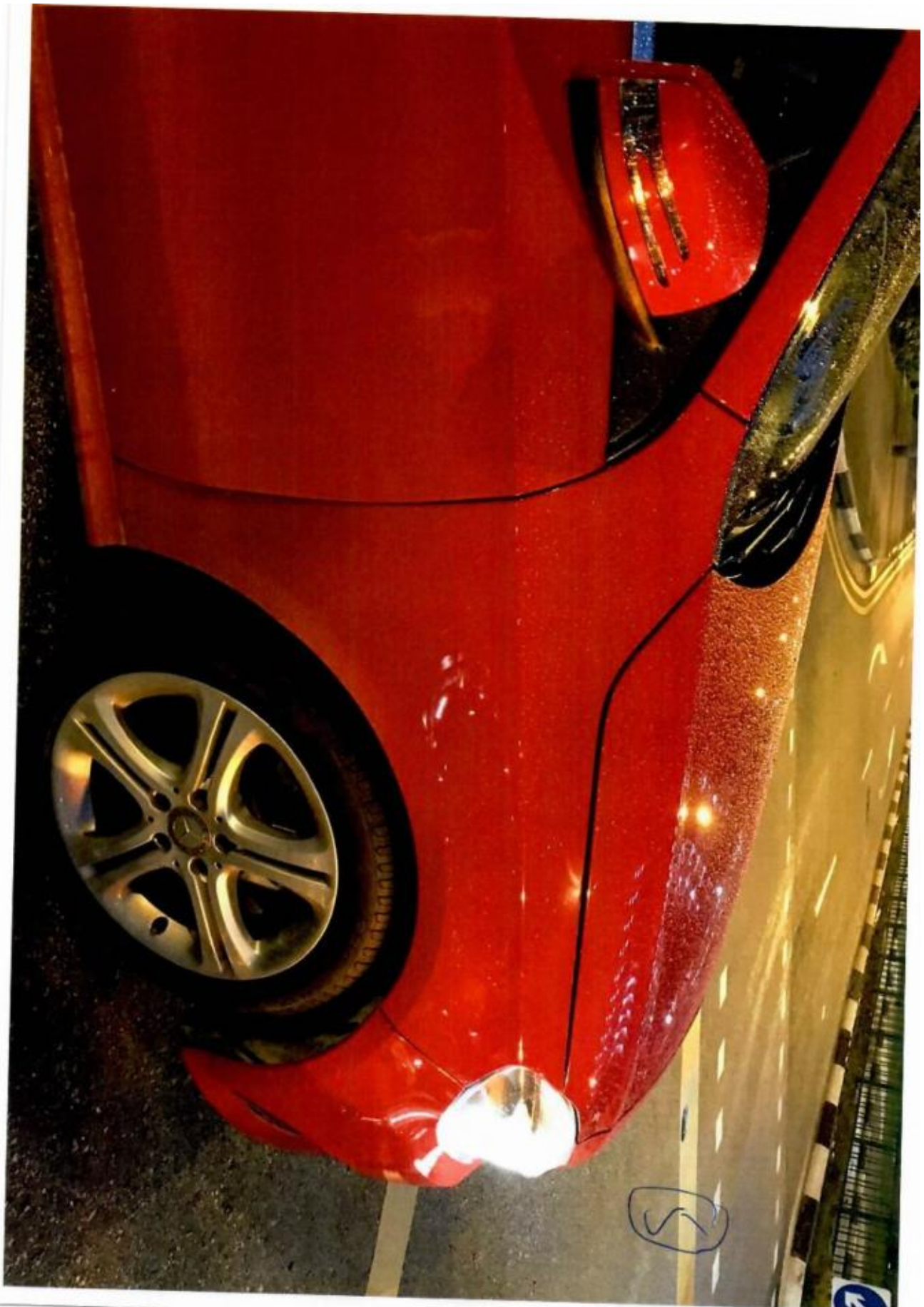
