#### **P.S. Formula for Write-Off Value of Taxi using Straight Line Depreciation Method**

##### **1. Depreciation of taxi per month:**

**= (Cost of taxi - PARF benefit at end of 8 years)/Life span of taxi (8 years) in months**

##### **2. Book value of taxi as at date of accident:**

**= (Depreciation per month from (1) x life span left as at date of accident) + PARF benefit at end of 8 years.**

##### **3. Write off value of taxi as at date of accident:**

**= Book value from (2) - PARF/COE rebate at date of accident - Salvage value of wreck**

**Computation of Write-Off value for SH6869D:-**

**1. Depreciation per month:**

= (S\$71,547.44 - S\$8,789.00) / 96 months (14/04/2011 to 13/04/2019)  
= S\$653.73

**2. Book value at date of accident:**

= (S\$653.73 x 32 months) + S\$8,789.00  
= S\$29,708.36

**3. Write-off value as at date of accident:**

= S\$29,708.36 - S\$10,253.00 - S\$10,511.00 - S\$280.00  
= S\$8,664.36
