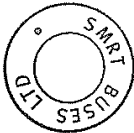

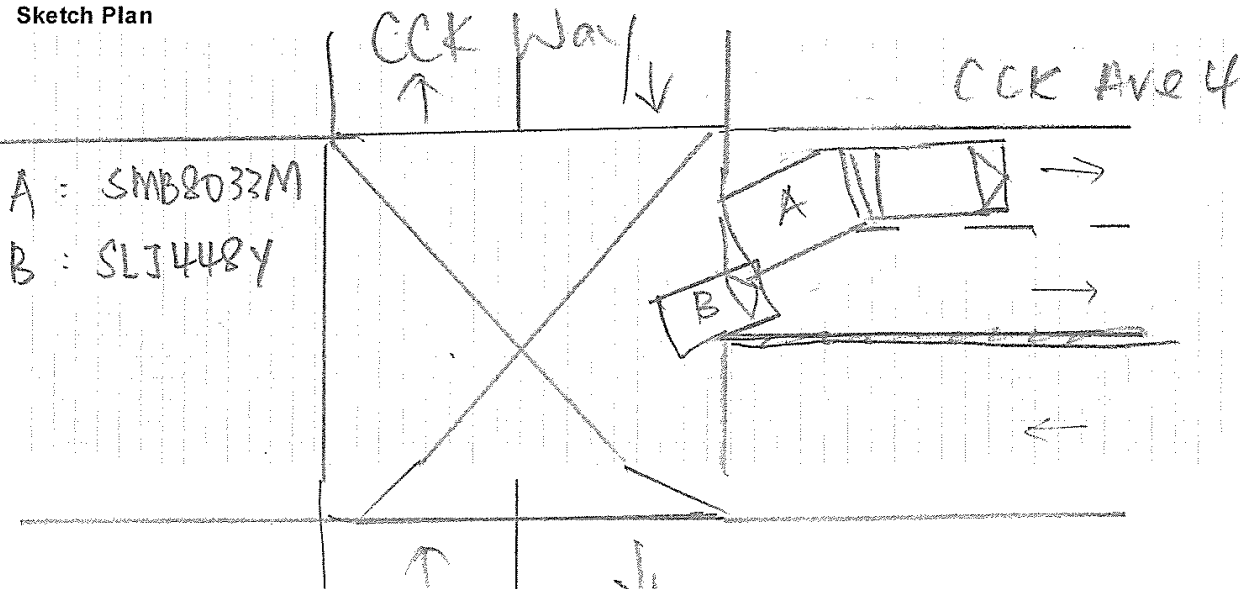

Sketch Plan



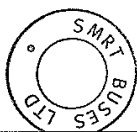

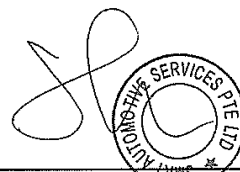
