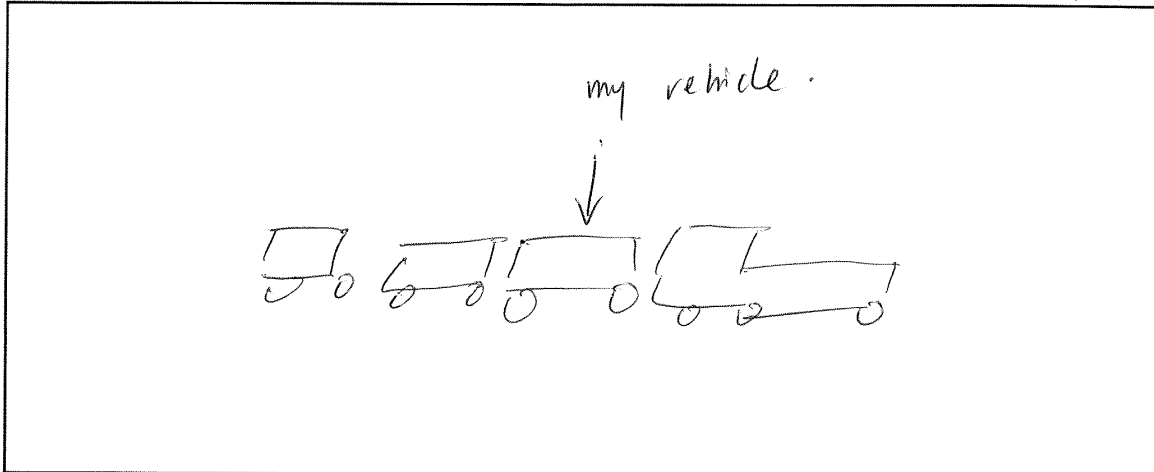

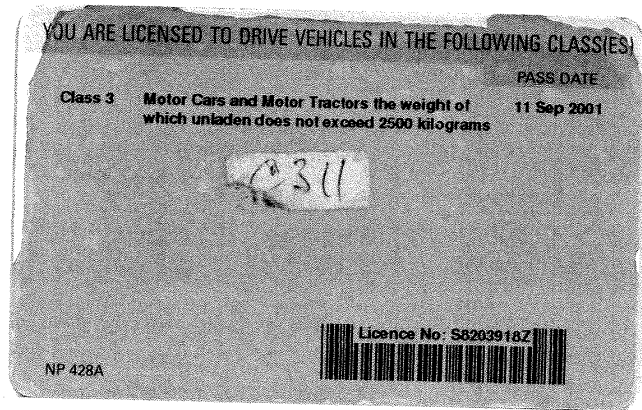
### Important note
