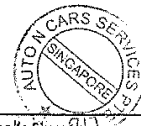


Sketch Plan #2 Pg. 1

C: SLK2412G




Yishun Ave 7 Lamp post 42

I wish lodge the report for claim against veh "B". 




