



- 1) Teng went for delivery to 301 Boon Keng Road on 28<sup>th</sup> June'18
- 2) Lorry was parked inside the building to unload the cargo
- 3) There was a trailer at loading bay who wants to go out and our lorry was blocking the way
- 4) So Teng had to drive the lorry forward in order to let the trailer moved out
- 5) The lorry behind door was opened
- 6) So Teng just latched it up at the side lorry on the left
- 7) While driving forward, the latched suddenly gave way & the left side behind door swing out
- 8) The behind left door hit the stationery van that was parked on the opposite side on the road
- 9) The van was parked on double red line which is a "NO PARKING" area
- 10) The left door of CIFIC lorry hit the left side of the van mirror all the way to the front door handle of the van
- 11) There was scratches mark found on the van starts from the left side mirror to the front door handle of the van.
- 12) The side left mirror of the van was also found loose after the hit. There are no other discrepancies found that what are stated as above.
