Circumstances of Accident

AT 5:14 PM ON 6TH JULY 2018. I WAS DRIVING ON THE PIE IN THE DIRECTION OF CHANGI AIRPORT AND I WAS ON THE EXTREME RIGHT LANE. TRAFFIC WAS FLOWING VERY SMOOTHLY AND I WAS CRUISING ALONG BEHIND A BLACK NISSAN LATIO KEEPING A DISTANCE OF AROUND 3-5 CAR LENGTHS AWAY. WE WERE DRIVING AT A SPEED OF ABOUT 75-80 KM/H WHEN THE BLACK NISSAN SUDDENLY JAMMED HIS BRAKES AND ATTEMPTED TO CUT TO THE LEFT LANE. SEEING THIS I IMMEDIATELY STEPPED HARD ON MY BRAKES TO SLOW DOWN. UNFORTUNATELY THE NISSAN ABRUPTLY CHANGED HIS MIND AND SWERVED BACK INTO MY LANE WHILE COMING TO A COMPLETE STOP IN FRONT OF ME. BY THIS TIME I WAS ALREADY JAMMING MY BRAKES FULLY AND MY CAR WAS ALREADY SKIDDING BUT IT WAS TOO LATE. I TRIED TO AVOID THE COLLISION BUT THERE WAS A BARRIER TO THE RIGHT AND THE FRONT LEFT OF MY CAR CLIPPED THE REAR RIGHT OF HIS BUMPER.



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At 5:14 PM on 6 July 2018, I was driving on the PIE in the direction of Changi Airport and I was on the extreme right lane. Traffic was flowing very smoothly and I was cruising along behind a black Nissan Latio keeping a distance of around 3-5 car lengths away. We were driving at a speed of about 75-80km/h when the Black Nissan suddenly jammed his brakes and attempted to cut to the left lane. Seeing this I immediately stepped hard on my brakes to slow down. Unfortunately the Nissan ~~detected~~ abruptly changed his mind and veered back into my ~~lane~~ lane while coming to a complete stop in front of me. By this time I ~~had~~ was already jamming my brakes fully and my car was already skidding but it was too late. I ~~was not able to~~ ^{tried to} avoid the collision but ~~as~~ there was a barrier to the right and the front left of my car clipped the rear right of his bumper.




