We refer to the above matter.

Third party reported that he was making a 3 pint turn(reverse), suddenly OI drove out from the handicap lot and both cars collided.

Our insured reported that he stopped beside the handicap lot to attend a urgent phone message. After that, he engaged driving gear to do a 3 point turn. He started to move forward and next thing he know is third party had collided onto his car.

We have contacted OID, Mr Koh to verify the nature of accident. He said that he was moving forward while third party reversed and both vehicles collided onto each other. OID agreed to let insurance to handle the matter.

Based on both parties report & circumstances of the accident, we would like to propose 50/50 as both parties should exercise caution (1 vehicle is moving out from stationary & the other was reversing).
